


Sub: - F.I.R regarding theft of electricity.

Sir,

I do hereby lodge a complaint being empowered by the Electricity act 2003 (Amendment Act 2007) against 1)Goutam Roy S/O- Ganes Roy and 2)Swapan Khamrai S/O-Late saktipada Khamrai both of vill-Ayma mohapur P.O.- Sahaspur PS- Anandapur Dist- Paschim Medinipur u/s 185(1)(b)&(a) of Electricity Act 2003 and it's Amendment Act 2007 for committing theft of Electricity as stated here under.


Today on 28/08/2018 at 12:40 hrs I, Pinaki Das,AE(E)&SM,AnandapurCCC S/O-Late Sujan kumar Das, along with Sri Arup Kr Singha Linesman,S/O-Murali Mohan Singha, Sri Nisith Pal TSH, S/O- Tapan Pal both of Anandapur CCC , Sri Aniruddha Pradhan,SE(F)of S&LP wing Vidyut Bhavan,Saltlake,kol-91 Sri Basudeb Das Special Officer,S/O- Late Rampada Das,Sri Birendra Nath Maity DE(E),S/O- Late Satyalal Maity and Sri Tapan Mukhi Gr-I TSH,S/O- Late Habu Mukhi all of S&LP wing, Paschim Midnapore Regional Office inspected the house of Goutam Roy and property of wbsedcl.On inspection it was found that he was using electricity unauthorizedly to run the electrical appliances at his house by the way of bypassing the existing meter(meter no-BB0459581)on tampering the incoming service cable before entering into the energy meter and tapped power with the help of one no single core paper insulated white colour copper wire through a changer(ON-OFF-ON)switch causing huge loss of revenue of WBSEDCL. Upon detection of theft we disconnected the tampered service cable and seized a portion of one no single core paper insulated white colour copper wire and a changer(ON-OFF-ON)switch preparing a seizure list duly signed by our inspection team members and representative of accused person. The seized articles were packed, labeled and sealed at the spot. We left the accused house at 13:10 hrs. after completion of all formalities.

. Then at 13:20 hrs we entered into the domestic premises of Swapan Khamrai which is situated near the house of Goutam Roy and held inspection.During inspection it was found that he was consuming electricity dishonestly and unauthorizedly by way of direct hooking from the nearest LT OH line with the help of two nos single core 4 sq mm pvc covered black colour aluminium wire and connected to his house wiring and running different electrical appliances causing huge loss of revenue of WBSEDCL. Upon detection of theft we disconnected the service cable and hooking line and seized a portion of two nos single core 4 sq mm pvc covered black colour aluminium wire approx. length-15 feet each with hooking arrangement preparing a seizure list duly signed by our inspection team members and representative of accused person. The seized articles were packed, labeled and sealed at the spot. We left the accused house at 13:50 hrs. after completion of all formalities.

So the above noted two accused persons 1)Goutam Roy S/O- Ganes Roy and 2)Swapan Khamrai S/O-Late saktipada Khamrai both of vill-Ayma mohapur P.O.- Sahaspur PS- Anandapur Dist- Paschim Medinipur have committed theft of Electricity u/s 185(i) (b)&(a) of Electricity act 2003 (Amendment Act 2007) and hence you are requested to take cognizance of the complaint treating it as an F.I.R.
