Sub: - F.I.R regarding theft of electricity u/s 135(i) (b) of Electricity act 2003 (Amendment Act 2007) against Keshab Bera, S/O-Lt Krishna Prasad Bera, Vill-Nayagram, PS-Anandapur, Dist-Paschim Midnapore.

Sir,

I do hereby lodge a complaint empowered by the Electricity act 2003 (Amendment Act 2007) against the above mentioned accused of the said act as stated here under.

Today on 28/01/2017 at 07.35 a.m. I, Sri Mansa Mal A.E. (E) & SM, along with Ashutosh Sharma, S.A.E., Kinkar Mahapatra S.A.E. of Anandapur CCC and Birendranath Maity Divisional Engineer, Sri Basudeb Das Special Officer, Tapan Mukhi Gr-1 TSH of S&LP wing from Paschim Midnapore Regional Office inspected 2 no's Shallow Tube Well premises (ID No-200074974 and 201474761) of Keshab Bera, S/O-Lt Krishna Prasad Bera, Vill-Nayagram, PS-Anandapur, Dist-Paschim Midnapore. On inspection it was found that Keshab Bera was using electricity unauthorizably to run his two no 5 HP Submersible Pump for agriculture purpose by the way of bypassing the existing meters having No-RGX77514 and IXB012066. He had done this bypass by directly connecting one no 3-Core, 4 SQ mm Black colour PVC Cable to the existing DTR LT side bushing which was in turn connected to 3 no, 16 SQ mm faded Black, white and Red colour PVC cable and this whole hooking line was then taken to the STW Pump Set which was installed in the agricultural field of Village Nayagram (Meter No-IXB012066 and ID No-201474761). From this hooking line he again tapped with the help of 3 no 16 so mm faded Black, white and Red colour PVC cable and running the STW Pump Set (Meter No- RGX77514 and ID No-200074974) located adjacent to the existing DTR. Upon detection of theft we disconnected both the service cables from the DTR LT side bushing and seized the hooking cables (first one 3.5 mtr long, second one 3 mtr long and third one 1 mtr long each) mentioned in the Seizure List. As theft of electricity was detected I seized the above noted articles in presence of the inspection team and the representatives of the accused duly signed by them. The seized articles were packed, labeled and sealed in the spot. We left the STW premises at about 08.10 a.m. WBSEDCL has faced huge revenue loss in this two no meter bypassing as a clear theft is detected.

So the accused has committed theft of Electricity u/s 135(i) (b) of Electricity act 2003 (Amendment Act 2007) and you are requested to take cognizance of the complaint and treat it as F.I.R.
