**Sub: - F.I.R regarding theft of electricity u/s 135(i) (b) of Electricity act 2003 (Amendment Act 2007) against 1) Susanta Pal, S/O-Lt Khudiram Pal, and 2) Arun Mana, S/O-Lt Khudiram Mana all of Vill-Gobindapur, PO-Kongerayma, PS-Anandapur, Dist-Paschim Midnapore.**

Sir,

I do hereby lodge a complaint empowered by the Electricity act 2003 (Amendment Act 2007) against the above mentioned accused of the said act as stated here under.

Today on 28/01/2017 at 08.40 a.m. I, Sri Mansa Mal A.E. (E) & SM, along with Ashutosh Sharma, S.A.E., Kinkar Mahapatra S.A.E. of Anandapur CCC and Birendranath Maity Divisional Engineer, Sri Basudeb Das Special Officer, Tapan Mukhi Gr-1 TSH of S&LP wing from Paschim Midnapore Regional Office inspected the Shallow Tube Well premises of **Susanta Pal, S/O-Lt Khudiram Pal, Vill-Gobindapur, PO-Kongerayma, PS-Anandapur, Dist-Paschim Midnapore**. On inspection it was found that **Susanta Pal** was using electricity unauthorizedly to run his 5 HP Submersible Pump for agriculture purpose by the way of bypassing the existing meter having No-YXB005695. He had done this bypass by connecting 3 no 16 SQ MM Black Colour, Aluminium Core PVC Cables directly to the outgoing port of the fuse unit (installed after the meter) from the 440 volt line. From the fuse unit this bypass line was taken to the STW pump set. Upon detection of theft we disconnected both the service cable and the hooking lines from the LTOH line and seized a portion (approx. 3.5 mtr each) of the hooking cables mentioned in the Seizure List along with hooking device. As theft of electricity was detected I seized the above noted articles in presence of the inspection team and the representatives of the accused duly signed by them. The seized articles were packed, labeled and sealed in the spot. We left the STW premises at about 09.10 a.m. WBSEDCL has faced huge revenue loss in this meter bypassing as a clear theft is detected.

On the same day at 09.20 a.m. at a stone throw distance from the first inspection, the inspection team inspected the electric connection of the STW Pump set of **Arun Mana, S/O-Lt Khudiram Mana of Vill-Gobindapur(Beuchabandi), PO-Kongerayma, PS-Anandapur, Dist-Paschim Midnapore** and found that he was also enjoying electricity unauthorizedly for running his 5 H.P. pump set (located in the agricultural field of Gobindapur) for agriculture purpose by the way of bypassing the existing meter having No-IX012246. He had done this bypass by connecting 3 no Copper-core 2.5 SQ mm PVC cables (one is Red, another is Yellow and the third one is Blue in colour) directly to the outgoing port of the fuse unit (installed after the meter) with the help of 3 no clips from his own purchased DTR low tension side bushing. Upon detection of theft we disconnected both the service cable and the bypass cables from the DTR LT side bushing and seized a portion (approx. 6 ft. long each) of the hooking cables mentioned in the Seizure List along with hooking device made of Aluminium bend supported by bamboo stick.

As theft of electricity was detected I seized the above noted articles in presence of the inspection team and the representatives of the accused duly signed by them. The seized articles were packed, labeled and sealed in the spot. We left the STW premises at about 09.55 a.m. WBSFDCL has faced huge revenue loss in this meter bypassing as a clear theft is detected.

So the above noted two accused namely accused **Susanta Pal Arun Mana** and have committed theft of Electricity u/s 135(i) (b) of Electricity act 2003 (Amendment Act 2007) and you are requested to take cognizance of the complaint and treat it as F.I.R.
