

SUB: FIR for theft of Electricity

Dear Sir,

I, Dipak Kumar Majhi, AE & Station Manager, Upperkuai C.C.C, W.B.S.E.D.C.L, S/O Upendra Nath Majhi, empowered by Electricity Act, 2003 (Amendment Act, 2007) lodge this complaint against **Mahon Kumar Dolai, S/o-Chandrakanta Dolai**, Village- Brambhangram, PO: Sirsa , PS: Anandapur, Paschim Medinipur existing consumer of WBSSEDCL having Consumer ID-213105204 for committing theft of electricity under section 135(1)(b) of Electricity Act, 2003 (Amendment Act, 2007) as stated here under :

On 12/10/2018 at about 13:05 Hrs myself alongwith Mrinal Kanti Singh, SAE(E), Debojyoti Jana, LM, Sanat Kumar Ghosh, LM, Laltu Nath, Sr TSH, all of Upperkuai C.C.C. entered into the domestic premises of **Mahon Kumar Dolai , S/o Chandrakanta Dolai , Village- Brambhangram, PO: Sirsa , PS: Anandapur, Paschim Medinipur** and held inspection. During inspection it was found that he was consuming electricity dishonestly and unauthorisedly by way of direct hooking from the nearest 1phase LTOH line with the help of two nos. multi core 7/16 SWG PVC Covered aluminium cable and connected to his domestic wiring and running different electrical appliances i.e bypassing the energy meter (L1806868). Thus, WBSSEDCL suffered huge loss of revenue. As theft was detected, we disconnected the hooking arrangements from the said premises and seized some portion of two nos. multi core 7/16 SWG PVC Covered aluminium cable with hooking arrangement approx length 05 feet each preparing a seizure list duly signed by the inspection team members. We packed, labeled and sealed the seized article at the spot. In spite of request, the representatives of the accused and local people refused to sign in the inspection report, seizure list and label. We left the premises at 13:35 Hrs after completion of all necessary formalities.

In the above noted circumstances , the aforesaid accused persons, namely **Mahon Kumar Dolai , S/o Sri Chandrakanta Dolai** has committed theft of electricity u/s 135(1)(b) of E. Act 2003 (Ammendmend 2007). So, he is liable to be prosecuted under the same section of law.

Due to some official work we are unable to lodge the F.I.R on 12.10.2018.

Hence, you are requested to take cognizance against the above accused person treating this complaint as an F.I.R.
