Sub: - F.I.R. against theft of Electricity.

Sir,
I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 to the effect that
1) Aditya Ghosh S/O – Haraballabh Ghosh & 2) Nityaranjan Ghosh S/O - Haraballabh Ghosh both are residing
at Vill - Murakata ,P.O-Mohoboni P.S.-Anandapur, Dist-PaschimMedinipur committed theft of electricity and
thereby they are all liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act,
2007 as stated here under.

Dated on 06.12.2018 at about 17.45 Hrs I, Sri Dipak Kumar Majhi AE& Station Manager, along with
Suvamoy Deb(SAE),Sanat Kumar Ghosh (LM), LaltuNath(TSH) all are of Upperkuai CCC entered into the
Domestic premises of the aforesaid 1) Aditya Ghosh S/O – Haraballabh Ghosh & 2) Nityaranjan Ghosh S/O -
Haraballabh Ghosh both are existing consumer of WBSEDCL and inspected their service connection and
W.B.S.E.D.C.L property of said premises.

i) During inspection at about 17.45 Hrs.it was found that Aditya Ghosh S/O – Haraballabh Ghosh who is
existing consumer of WBSEDCL having Consumer ID no-200693938 of Vill - Murakata ,P.O-Mohoboni
P.S.-Anandapur, Dist-PaschimMedinipur was consuming electricity dishonestly by the way of direct hooking from
nearby 1 phase L.T. O.H. line of WBSEDCL with the help of 1 no two core 4.0 sq mm Aluminum pvc covered
aluminum cable connected to his house wiring and consuming electricity i.e meter bypassing (Meter No TA014963) and
thereby causing huge revenue loss of WBSEDCL. As theft was detected, I, with the help of my staff,
disconnected his service and unauthorized hooking connection and seized a portion of 1 no two core 4.0 sq mm
Aluminum pvc covered aluminum cable approx length 5 feet each with one no hooking device under a proper
seizer list dully singed by the witnesses and our inspection team members. In spite of request his
representative refused to sign on the seizure list. The seized article were properly packed, labeled & sealed at
the spot. Details of findings were incorporated in the attached inspection report.

During another inspection about 18.05 Hrs. at the same place it was found that Nityaranjan Ghosh S/O -
Haraballabh Ghosh being consumer of WBSEDCL having Consumer ID no-202012454, was consuming
electricity dishonestly & unauthorisedly by way of direct hooking from nearby existing 1-phase LTOH line of
WBSEDCL with the help of two nos 7/20 SWG multi core PVC covered aluminum cable and connected to
his own arranged house wiring and running his different domestic appliances i.e bypassing the energy meter
(meter no-DDB177061) and thereby causing huge revenue loss of WBSEDCL. As theft was detected, I, with
the help of my staff, disconnected unauthorized hooking connection and seized a portion of two nos 7/20
SWG multi core PVC covered aluminum cable approx length 5 feet each along with 02 nos hooking devices
under a proper seizer list dully singed by our inspection team members. In spite of request his representative
refused to sign on the seizure list. The seized article were properly packed, labeled & sealed at the spot.
Details of findings were incorporated in the attached inspection report.

This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL

A copy of seizure lists and seized articles (duly packed, labeled and sealed at the site of inspection) are being
submitted herewith. The inspection team left the aforesaid premises on completion of all inspection at about 18.20 hrs.

The aforesaid accused persons namely; 1) Aditya Ghosh S/O – Haraballabh Ghosh & 2) Nityaranjan Ghosh S/O -
Haraballabh Ghosh committed an offence & thereby they are liable to prosecute under section 135(1)(a) of the
Electricity Act, 2003 and its Amendment Act, 2007.

Due to some urgent official work we are unable to lodge the FIR on dated 06.12..2018 .

You are requested to take cognizance of this complaint and treat it as FIR.
