Sir,  
I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 to the effect that **Rekha Chakraborty**, C/O: **Lt. Sukumar Basu of Vill + P.O—Mohoboni, P.S.-Anandapur, Dist-Paschim Midnapur** committed theft of electricity and thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

Dated on 19.06.2019 at about 12.30 Hrs. I, Sri Dipak Kumar Majhi, AE&Station Manager Upperkuai CCC along with Suvamoy Deb (SAE) and Debojyoti Jana (LM) all attached to Upperkuai CCC entered into the Domestic premises of the aforesaid **Rekha Chakraborty who was existing consumer of WBSEDCL having Consumer ID no-213104830** and inspected his Domestic connection and W.B.S.E.D.C.L property of said premises.

During inspection it was found that **Rekha Chakraborty, C/O: Lt. Sukumar Basu** was consuming electricity dishonestly by the way of directly hooking from near by single phase LTOH line of WBSEDCL with the help of two nos multi-core 1.5 sq mm copper cable directly connected to his house wiring for effecting unauthorized connection i.e. bypass of energy meter (**Meter No-L3530197**) and enjoying unauthorized electricity for domestic purpose. Details of findings were incorporated in the attached inspection report.

This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. The hooking lines of accused persons were disconnected and service line was disconnected in presence of the attending personnel and their representatives.

A portion of the hooking accessories i.e. two nos multi-core 1.5 sq mm copper cable along with two nos hooking device were duly seized and labeled by the undersigned in presence of the members of the inspection team at the site. In spite of request their representatives refused to sign on the seizure list.

A copy of seizure lists and seized articles (duly packed, labeled and sealed at the site of inspection) are being submitted herewith. The inspection team left the aforesaid premises on completion of inspection at about 13.00 Hrs.

The aforesaid accused persons committed an offense & thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007.

You are requested to take cognizance of this complaint and treat it as FIR.
