I SI Sayantan Banerjee Officer in Charge Anandapur Police Station do hereby lodge this suo-motto complaint against BJP leaders Shri Dilip Ghosh, State President of BJP, Shri Mukul Roy, Smt Bharati Ghosh, Smt, Antara Bhattacharyee, Shri Sayantan Bose, Shri Ajay Pradhan, Shri Rangaraj Batabyal, Shri Debashis Chatterjee, Md. Selim, Shri Swapan Chakraborty, and ten thousand others BJP leaders and supporters.

The fact in brief is that, on 25/06/19 Smt, Antara Bhattacharyee, President, BJP Ghatal Sangathanik Jila, prayed for a public meeting at Anandapur Vidyasagar Sporting Club Ground on 29/06/19 at 11:00 hrs. She did not submitted any no objection certificate of land owner, prayer for mike and other related paper documents along with the application. On 26/06/19 several times over phone as well as over email, through Whatsapp and through letter I intimated following persons Smt, Antara Bhattacharyee, Shri Ajay Pradhan and Shri Ranjaraj Batabyal that, they were not allowed to organize public meeting on 29/06/19 at Anandapur Vidyasagar Sporting Club ground, considering the present sensitive law and order situation and the ongoing incident of political classes happing in the Anandapure PS area and its adjacent PS areas, myself requested the organizers to post pond the date of their meeting. I also diarized the matter Vide Anandapur PS GDE No-937 & 952 dt 26/06/19.

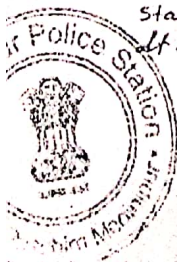
BJP organizers did not pay any heed to my direction. Today on 29/06/19 in between 08:00 hrs to 14:00 hrs the above mentioned BJP leaders and about ten thousand others BJP leaders and supporters gathered un lawfully at Anandapur Vidyasagar Sporting Club Ground and organize public meeting and procession without any permission Shri Dilip Ghosh, State President of BJP, Shri Mukul Roy, Smt Bharati Ghosh, Smt, Antara Bhattacharyee, Shri Sayantan Bose, Shri Ajay Pradhan, Shri Rangaraj Batabyal, Shri Debashis Chatterjee, Md. Selim, Shri Swapan Chakraborty, leaded the unlawful gathering, meeting and procession. The above mention leaders wantonly gave provocation with intent to cause riot. They promoted enmity between BJP supporters and others. They threatened TMC leaders and supporters and Administration with dire consequences. As a result immediately after the meeting BJP supporters attacked Khetua Police Camp, political rioting took place at different places under Anandapur and Keshpur PS Jurisdiction.

I therefore, lodge this suo-motto complaint against BJP leaders Shri Dilip Ghosh, State President of BJP, Shri Mukul Roy, Smt Bharati Ghosh, Smt, Antara Bhattacharyee, Shri Sayantan Bose, Shri Ajay Pradhan, Shri Rangaraj Batabyal, Shri Debashis Chatterjee, Md. Selim, Shri Swapan Chakraborty, and ten thousand others BJP leaders and supporters under section 143/153a/117/154/187/188/506 IPC R/W 32 Police Act for gathering un lawfully, organizing procession without permission, wantonly giving provocation with intent to cause riot, abetting commission of offence, disobedience to order, criminal intimidation and arranged for its investigation.
