In producing here with arrested accd. person namely Achinta Karan (39) S/o- Lt Bhaktipada Karan of Vill- Pebua, PO- Kanasole, PS- Anandapur, Dist- Paschim Medinipur along with the following seized articles as per seizure list . I, ASI Subrata Mukhopadhyay of Anandapur PS do here by lodge a written complaint against the above noted accd. person to the effect that today (06.09.2019) while I was performing PS mobile duty at PS area accompanied by detailed forces vide C.C. No- 1549/19, dated- 06.09.19 at about 16:15 hrs received a credible information vide Anandapur PS GDE No- 231 dt- 06.09.19 at 20:45 hrs from duty officer which was received from unknown caller over Telephone that a clandestine business of foreign liquors is running illegally at village Pebua, Anchal No- VI in the Tea stall of the above noted accd. person. After taking information of duty officer and as per direction of O/C Anandapur PS I, along with available force went there and conducted raid at the Tea stall and found that the huge quantity of foreign Liquors kept inside the Tea stall. On interrogation the above noted accd. person confessed that he is running this illegally for business purpose. On demand the above noted accd. person failed to produced any valid license or documents in support of such illegal foreign liquor. As such I seized about 13 ltrs. of foreign Liquors containing in 30 bottles of various brand and various volume under proper seizure list prepared by me duly signed by the accd person and witnesses. I also tried to get signature some local persons upon seizure list but nobody appeared as the above noted accd. person belongs same locality. During further interrogation the above noted accd. person confessed his guilt that he is running this illegally for business purpose. As such I arrested him after preparing memo of arrest and obtained his signature upon it after observing all formalities of Ld Apex court as he is running business of foreign Liquor unauthorized.

The above noted arrested accd. person has committed an offence punishable U/S 46 (A) of The Bengal Excise Act and a FIR may kindly be registered against him and oblige.
