Sir,

I, the undersigned, do hereby lodge a complaint being empowered by the Electricity Act 2003 and its amendment act 2007 against 1) Bablu Singh, 2) Hablu Singh, 3) Mangal Singh all S/O- Lt. Banchu Singh and 4) Raghunath Munian, S/o- Khokan Munian of Village-Anandapur (Bauripara), P.O- Anandapur, P.S- Anandapur, Dist-Paschim Medinipur for committing theft of electricity U/S-135(1)(a) of Electricity Act 2003 and its amendment act 2007 as stated hereunder.

On 25.11.2019 at 14.05 hrs I, Sri Rabindranath Jana, Station Manager of Anandapur CCC, S/O- Lt. Sagar Chandra Jana along Sri Tathagata Mukherjee, J.E. Grade -II(E), S/O- Shekhar Mukherjee, Sri Arup Kumar Singha, LM, S/O-Murali Mohan Singha, Sri Trilochon Bagdi, S/O-Late Baul Bagdi and other technical staffs of Anandapur CCC and Sri Birendra Nath Maity DE(E), S/O-Late Satyalal Maity, Sri Basudeb Das, SO, Midnapore regional office entered into the domestic premises Bablu Singh and inspected his domestic premises and properties of WBSEDCL.

During inspection it was found that Bablu Singh was consuming electricity dishonestly and unauthorizedly by way of direct hooking from nearest LTOH line with the help of 1 no. 2 core 4 sqmm PVC covered black coloured Aluminium cable and connected to his domestic premises and running different electrical appliances causing huge amount of revenue loss of WBSEDCL. Upon detection of theft we disconnected the hooking line and seized some portion of 1 no. 2 core 4 sqmm PVC covered black coloured round shape Aluminium cable approx. length 6 ft with hooking arrangement preparing a seizure list duly signed by our inspection team member. We packed, labeled and sealed the seized article at the spot. In spite of request the local people and representative of accessed person refused to sign in the inspection report seizure list and label. We left the premises at 14.35 hrs. after completion of all the formalities.

Then at 14:40 hrs. we held inspection in the domestic premises of Hablu Singh which is situated beside The house of Bablu Singh was consuming electricity dishonestly and unauthorizedly by way of direct hooking from nearest LTOH line with the help of 1 no. 2 core 4 sqmm PVC covered black coloured Aluminium cable and connected to his domestic premises and running different electrical appliances causing huge amount of revenue loss of WBSEDCL. Upon detection of theft we disconnected the hooking line and seized some portion of 1 no. 2 core 4 sqmm PVC covered black coloured round shape Aluminium cable approx. length 7.5 ft with hooking arrangement preparing a seizure list duly signed by our inspection team member. We packed, labeled and sealed the seized article at the spot. In spite of request the local people and representative of accessed person refused to sign in the inspection report seizure list and label. We left the premises at 15.10 hrs. after completion of all the formalities.

Then at 15:55 hrs. we held inspection in the domestic premises of Mangal Singh which is situated beside The house of Bablu Singh was consuming electricity dishonestly and unauthorizedly by way of direct hooking from nearest LTOH line with the help of 1 no. 2 core 4 sqmm PVC covered black coloured Aluminium cable and connected to his domestic premises and running different electrical appliances causing huge amount of revenue loss of WBSEDCL. Upon detection of theft we disconnected the hooking line and seized some portion of 1 no. 2 core 4 sqmm PVC covered black coloured round shape Aluminium cable approx. length 10 ft with hooking arrangement preparing a seizure list duly signed by our inspection team member. We packed, labeled and sealed the seized article at the spot. In spite of request the local people and representative of accessed person refused to sign in the inspection report seizure list and label. We left the premises at 15.45 hrs. after completion of all the formalities.




And then at 15:55 hrs. we held inspection in the domestic premises of Mangal Singh which is situated at the same hamlet was consuming electricity dishonestly and unauthorizedly by way of direct hooking from nearest LTOH line with the help of 1 no. 2 core 6 sqmm PVC covered black coloured Aluminium cable and connected to his domestic premises and running different electrical appliances causing huge amount of revenue loss of WBSEDCL. Upon detection of theft we disconnected the hooking line and seized some portion of 1 no. 2 core 4 sqmm PVC covered black coloured round shape Aluminium cable approx. length 9 ft with hooking arrangement preparing a seizure list duly signed by our inspection team member. We packed, labeled and sealed the seized article at the spot. In spite of request the local people and representative of accessed person refused to sign in the inspection report seizure list and label. We left the premises at 16.20 hrs. after completion of all the formalities.

In the above noted circumstances the above mentioned 4 accused persons 1) Bablu Singh, 2) Hablu Singh, 3) Mangal Singh all S/O- Lt. Banchu Singh and 4) Raghunath Munian, S/O- Khokan Munian of Village-Anandapur (Bauripara), P.O- Anandapur, P.S- Anandapur, Dist-Paschim Medinipur have committed theft of electricity U/S-135(1)(a) of Electricity Act 2003 and its amendment Act 2007 for which they are liable to be prosecuted under the same section of law.

So you are requested to please take cognizance treating this complaint as an FIR.
