Sub: -FIR against theft of electricity.

I, the undersigned, do hereby lodge a complaint being empowered by the Electricity Act 2003 and its amendment act 2007 against 1) Ranabir Ghosh & 2) Dipak Ghosh both S/O- Purna Ghosh of village-P.O-Kotai, P.S-Anandapur, Dist-Paschim Medinipore for committing theft of electricity U/S-135(1)(a) of Electricity Act 2003 and its amendment act 2007 as stated hereunder.

Today 20/12/2019 at 11.35 hrs I, Rabindranath Jana, SM Anandapur ccc S/O-Lt Sagar Chandra Jana along with, Sri Basudeb Das, SO, S/O-Late Rampada Das, Sri Subhadip Mitra, TSH, S/O-Late Asim Kumar Mitra both of S&LP wing Paschim Medinipore regional office, Sri Tathagata Mukherjee, Jr. Engg Grade-II, S/O-Sheklar Mukherjee, Sri Arup Kumar Singha, LM, S/O-Murali Mohan Singha, Sri Koushik Das, Sr. TSH, Late Rabindranath Das, Sri Kalyan Kumar Roy, TSH, S/O-Late Kirtiban Ray and other technical staffs of Anandapur CCC entered into the Domestic premises of Ranabir Ghosh and held inspection.

During inspection it was found that Ranabir Ghosh was consuming electricity dishonestly and unauthorizedly by way direct hooking from the nearest LTOH line with the help of one nos 2 core 4 sqmm black colour round shaped aluminum cable and connected to his house wiring and running different electrical appliances in his deemed disconnected premises (Consumer ID-212142113) causing huge loss of revenue to WBSEDCL. Upon detection of theft we disconnected the hooking line and seized some portion of 2 core 4 sqmm black colour round shaped aluminum cable measuring about 7ft with hooking arrangement preparing a seizure list duly signed by our inspection team members. We packed, labeled and sealed the seized article at the spot. In spite of request the local witnesses and representative of accused person refused to sign in the inspection sheet, seizure list and label. We left the premises at 12.05 hrs after completion of all the formalities.

Then at 12.10 hrs we inspected the domestic premises of Dipak Ghosh which is situated beside the house of Ranabir Ghosh.

During inspection it was found that Dipak Ghosh was consuming electricity dishonestly and unauthorizedly by way direct hooking from the nearest LTOH line with the help of one nos 2 core 4 sqmm white colour flat shaped aluminum cable and connected to his house wiring and running different electrical appliances in his domestic premises causing huge loss of revenue to WBSEDCL. Upon detection of theft we disconnected the hooking line and seized some portion of 2 core 4 sqmm white colour flat shaped aluminum cable measuring about 6ft with hooking arrangement preparing a seizure list duly signed by our inspection team members. We packed, labeled and sealed the seized article at the spot. In spite of request the local witnesses and representative of accused person refused to sign in the inspection sheet, seizure list and label. We left the premises at 12.40 hrs after completion of all the formalities.

In the above noted circumstances the above noted two accused persons 1) Ranabir Ghosh & 2) Dipak Ghosh both S/O- Purna Ghosh of village-P.O-Kotai, P.S-Anandapur, Dist-Paschim Medinipore have committed offence U/S-135(1)(a) of Electricity Act 2003 and its amendment Act 2007 for which they are liable to be prosecuted in the same section of law.

So you are requested to please take cognizance treating this complaint as an FIR.
