Sir,

I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 against Tarak Kamal, S/O : Mantri Kamal, Vill : Ghoradhaura, PO : Sirsha, PS : Anandapur, Dist-Paschim Medinipur existing Consumer of WBSEDCL having Consumer ID : 200447912 for committing theft of electricity and thereby he is liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

On dated on 27.12.2019 I, Sri Dipak Kumar Majhi, AE&Station Manager along with Suvamoy Deb (SAE) Tantu Nath(Sr. ISI), Sanat Kumar Ghosh (LM) all attached to Upperkuai CCC and Sri Birendra Nath Maity DI (I), Subhadip Mitra(TSI) are attached to the S&LP Unit, Paschim Medinipure Region Office entered into the Domestic premises of the aforesaid accused person successively and inspected his hooking lines and property of WBSEDCL.

- 1) At about 13.20 Hrs, we inspected the house of Tarak Kamal, S/O : Mantri Kamal, Vill : Ghoradhaura, PO : Sirsha, PS : Anandapur, Dist-Paschim Medinipur during inspection it is found that he was consuming electricity dishonestly and unauthorizedly by the way of direct hooking from the nearest LTOH line of WBSEDCL with the help of 2 nos single core 1.5 sq mm PVC covered yellow colored Copper wire and connected to his house wiring and running different electrical appliances in his domestic premises i.e by passing the *Energy Meter : T02839898*. This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. As theft is detected I with the help of my staff disconnected the hooking line and service line and seized some portion of 2 nos single core 1.5 sq mm PVC covered yellow colored Copper wire measuring approx length 10 feet each with hooking arrangements preparing a seizure list duly signed by our inspection team members. We packed, labelled and sealed the seized articles at the spot and we left the safe place at about 13.50 Hrs. after making our all formalities

Here to note that in spite of request the representative of aforesaid four accused person Tarak Kamal, S/O : Mantri Kamal, Vill : Ghoradhaura, PO : Sirsha, PS : Anandapur, Dist-Paschim Medinipur and local people refuse to signature in the inspecting reports, seizer list and lables.

In the above noted circumstances the above noted accused has committed theft of electricity and he is liable to prosecuted U/S 135(1)(b)(Meter By Pass i.e *Energy Meter : T02839898*) of Electricity Act 2003 (Amendment Act, 2007).

Hence you are requested to take cognizance treating this complaint as FIR.
