Sub:- Prayer for lodging complaint.

Sir,

In producing here with one seized tractor having Reg No- WB-33C/3654 loaded with sand under proper seizure list. I SI Ananda Mohan Pandit beg to report that today (01.03.2020) I along with C/2385- Durjodhan Hazra, NVF- Pravash Mandal, Spl HG- Subodh Ch Hansda, LC- 715- Sunita Chaulia, LC- 964- Santimaya Giri were performing mobile duty vide Anandapur PS GDE No- 10 dtd- 01.03.2020 and C.C. No- 233/2020. At about 09.15 hrs in course of my mobile duty received a telephonic information that an illegal sand mine is going on by the river side at village Durya under Anandapur PS. Accordingly I informed O/C Anandapur PS and as per instruction I along with force left for village Durya to work out the information. Seeing the Police come one driver of a tractor stop the tractor on the road and escaped. I went to the spot where the tractor was parked and saw the registration number of the tractor as WB-33C/3654 and the tractor was loaded with sand. I asked the local people and came to learn that the owner and the driver of the said tractor were digging the bank of the river and loaded sand on the said tractor for transportation illegally. Accordingly I seized the said tractor loaded with sand under proper seizure list duly signed by the local witnesses.

Under the above fact and circumstances I pray that a specific case with proper section of law may kindly be initiated against the owner and the driver of the tractor having registration number WB-33C/3654.
