In production herewith three (03) arrested accused persons namely 1. Indrajit Dey (21 Yrs) S/O- Sukumar Dey of Vill- Teghari, PS- Anandapur, Dist- Paschim Medinipur, 2. Arun Pal S/O- Amar Pal and 3. Kartick Saha S/O- Lt. Rabi Saha both of Vill- Remeswarpally, PO- Bethuadihi, PS- Nakashipara, Dist- Nadia along with the following seized articles as per seizure list. I SI Ananda Mohan Pandit (59 Yrs) S/O- Lt. Kedar Nath Pandit of Vill- Haribharh, PS- Belda, Dist- Paschim Medinipur, presently posted as SI of Police, Anandapur PS, Dist- Paschim Medinipur here by lodge suo-moto complaint against above noted accused persons to the effect that on 09.04.2020 at about 22:05 hrs while performing night mobile duty under Anandapur PS area vide Anandapur PS CC No- 717/20 Dt. 09.04.2020 and received from source information that above noted accused persons stored chemical materials (Explosive Substance) at Vill- Teghari, under Anandapur PS, and dispatched the same to other places. I informed the fact to duty officer SI Dipak Kumar Pandey, of Anandapur PS which was diarized vide Anandapur PS GDE No- 24 dt. 09.04.2020 and informed to OC Anandapur PS and other superiors. As per kind instruction of superiors I left for Teghari village to work out the information. After arrival at village Teghari, I found that one Indrajit Dey (21 Yrs) S/O- Sukumar Dey of Vill- Teghari, PS- Anandapur, Dist- Paschim Medipur stored/hoarded chemical materials (explosive substance) like as Sodium Hypochlorite (NaOCl), solution 8% which is combustible article, endanger for human life. With help of Arun Pal S/O- Amar Pal and, 3. Kartick Saha S/O- Lt. Rabi Saha both of Vill- Remeswarpally, PO- Bethuadihi, PS- Nakashipara, Dist- Nadia he try to transmit / dispatch Sodium Hypochlorite (NaOCl), solution 1% (100 Pcs Jerkin of 5 KG) through vehicle having Reg. No- WB-51A-2282. I asked said Indrajit Dey to produce valid documents in support of hoarding such amount of chemical, but he fail to produce any valid documents. Accordingly, I seized One thousand (1000 Pcs Jerkin of 5 KG containing Sodium Hypochlorite (NaOCl), solution 1% in proper seizure list duly signed witnesses. Then I also seized valid documents of vehicle having Reg. No- WB-51A-2282, DL book of the driver including vehicle having Reg. No- WB-51A-2282. During raid above noted accused persons tried to escape, after hot chasing I somehow arrest 1. Indrajit Dey (21 Yrs) S/O- Sukumar Dey of Vill- Teghari, PS- Anandapur, Dist- Paschim Medinipur, 2. Arun Pal S/O- Amar Pal and 3. Kartick Saha S/O- Lt. Rabi Saha both of Vill- Remeswarpally, PO- Bethuadihi, PS- Nakashipara, Dist- Nadia after maintaining all formalities according to Apex court of India, and guideline of HRC & NHRC. During further interrogation the above noted accused persons confessed their guilt that they are hoarding such chemical materials (explosive substance) illegally and unauthorizedly for business purpose which is endanger to human life.

Under the above fact and circumstances, as he was hoarding such volume of chemical materials illegally. I do hereby submit a complaint to start a specific case under proper section of law.
