Most respectfully, I ASI/2671- Suvashis Mukherjee of Anandapur PS beg to state that while myself along with force i.e C/1549- Nimai Saha, NVF-18120835 Gopen Mahata, NVF-18120688 Biswajit Pramanik, JLC/922- Somia Maity, JLC/865- Sudipa Ghosh, LC-2190- Bithika Das Baidya, LC/261- Joyashree Bera are performing Mobile duty at Anchal No III, Amanpur GP, vide Anandapur P.S. C.C No- 961 /2020 dtd- 17.08.2020 and GDF No- 593, dtd- 17.08.2020 then I received a telephonic Information that some local people gathered in front of Anchal - III, Amanpur GP Office at Piasala village violating Lock down.
