I ASI Amit Chatterjee(47Yrs) S/O- Lt. Inan Ranjan Chatterjee of 29/146 Vivekananda Road Maikelpally, P.O- Sheorapuly, PS- Sherampur, Dist- Hooghly, presently posted at Anandapur PS, Dist- Paschim Medinipur here by lodge suo-moto complaint against following persons namely (1) Manu Gayen S/O- Lt. Majed Gayen of Rajardanga, (2) SK Mofi S/O- SK Mursed of Rajardanga, (3) Sanku Mallick S/O- Lt. Nabira Mallick of Bankata, (4) Malin Mallick S/O- Siraj Mallick of Bankata, (5) Momin Sha S/O- Maju Sha of Bankata, (6) Dulu Mallick S/O- Lt. Hasen Mallick of Bankata, (7) Atabul Mallick S/O- Lt. Habu Mallick of Bankata, (8) Usub Sha S/O- Lt. Irsad Sha of Bankata, (9) SK Faju S/O- Lt. SK Hossian of Bankata, (10) SK Abdul Gaffar S/O- Lt. SK Kurban, (11) Saiyed Ali Mallick S/O- Fakir Mallick of Bankata, (12) Siraj Mallick S/O- Khan Bahadur Mallick of Bankata, (13) SK Tahedar S/O- Lt. SK Mantaz of Bankata, (14) Hasu Sha S/O- Badal Sha of Bankata, (15) SK Lak S/O- Lt. SK Lasgar of Khapara all of PS- Anandapur, Dist- Paschim Medinipur and 40 others to the effect that on 15.09.2020 at about 17:15 hrs received an information that in between 16:35 hrs to 17:05 hrs some persons under leader ship of SK Mofi S/O- SK Mursed and Manu Gayen S/O- Lt. Majed Ali Gayen both of Vill- Rajardanga, PS- Anandapur Dist- Paschim Medinipur being with armed with deadly weapons, explosive and bow and arrow, divided in two groups charged bomb on the road of Mallick chawk (Bankata) and also broke the asbestos which was diarized vide Anandapur PS GDE No- 537 dt. 15.09.2020 and as per instruction of OC, Anandapur PS I ASI Amit Chatterjee, C/1978 Satiswar Murmu, NVF-18120739 Rajib Koley, NVF-18120624, NVF-18120597 Tapas Dey, Pravas Mandal vide Anandapur PS CC No- 1150 had gone to village Bankata to work out the information. After arrival at village Bankata conducted raid and managed the situation. During raid above noted accused persons left from the place. During raid following materials have been seized - (1) Ten(10) Pcs arrow made bamboo, (2) Two (02) Pcs bow made, (3) Three (03) Pcs live bomb, (4) Some remanants of blasted bomb, (5) Some broken bricks, (6) Some marble, (7) Six (06) Pcs lathi, (8) Some broken parts of asbester, (9) Some burned sample earth mixed with explosive and (10) Some sample earth.

Hence I submit suo-moto complaint against the above noted accused persons to start a case in proper section of law.
