In producing herewith the accd. (1) Tajul Bhangi (45 Yrs) S/O-Lt Hamid Bhangi (2) Maidul Gayen (36 Yrs) S/O-Najrul Gayen and (3) Atabul Khan (35 Yrs) S/O-Mabed Khan all of Vill-Anandapur Rajardanga, PS-Anandapur, Dist-Paschim Medinipur under arrest I beg to lodge a complaint agst. them to the effect that ASI Pankaj Kumar De of Anandapur P.S. along with C/1549 Nemai Saha, NVF- 18120835 Gopen Mahata and HG- 150099 Pabitra Mandal were on night mobile duty in G.P. No. IX Anandapur area under P.S. Anandapur vide C.C. No. 1318/20 dt 15.10.2020 following deterioration of Law and Order situation in the locality where political hassles amongst supporters of BJP and TMC are being reported from every nook & corners of the P.S. area during these days. In course of their duty they received information from OC, Anandapur PS that, some political hooligans and rowdies belong to BJP attacked police force and the vehicle at Rajardanga village under GP No. IX Anandapur Rajardanga, PS. Anandapur. Seeing presence of Police personal, the miscreants started shouting using filthy languages with threat of causing dire consequence to the Policemen on duty. The Police party straightway started chasing them as they were wanted in other cases of Anandapur P.S. and continuously creating disturbance to villagers. While chasing the miscreants, they anticipating arrest, fermented the invited local villagers (BJP supporters) who encircled the Police Party from different corners with a rioting mode being armed with lathi, iron rod, bricks, arrow and bow etc and started indiscriminate pelting of break bats and assaulted them with iron rods & Lathis with a view to kill them on the spot. After hot chase we are able to apprehend (1) Tajul Bhangi (45 Yrs) S/O-Lt Hamid Bhangi (2) Maidul Gayen (36 Yrs) S/O-Najrul Gayen and (3) Atabul Khan (35 Yrs) S/O-Mabed Khan all of Vill-Anandapur Rajardanga, PS-Anandapur, Dist-Paschim Medinipur. In this time others namely Manu Gayen S/O- Lt. Majed Gayen of Rajardanga, and SK Mofi S/O- SK Mursed of Rajardanga and some others fled away towards the village Rajardanga. Aggressive frantic rowdies of Rajardanga forming an unlawful assembly being armed with lathi, iron rods, brick bates bow and arrow etc. caused severe injuries to C/1549 Nemai Saha, NVF- 18120835 Gopen Mahata and HG- 150099 Pabitra Mandal. On subsequent information, O.C. Anandapur with other officers and force came & rescued them and sent Mohoboni P.H.C and for treatment. One Public Maruti Van having Regn. Nos. WB 34AB 6985 was also damaged by the accused persons. After search I seized some Lathi, Arrow and bow, brick bates, from place of occurrence i.e. at village Rajardanga.

I, therefore, request before your kind self that necessary arrangement may kindly be made for starting a case in proper section of law and arrange for its investigation.
