Most respectfully, I ASI/619 Avijit Samaddar of Anandapur PS beg to state that while myself along with force i.e C/1033 Adesh Das , NVF-Prasenjit Karak, NVF-Subhas Mahata, LC-262 Puja Roy, LC/2061 Soma Sahoo are performing Mobile duty at Anchal No III, Amanpur GP vide Anandapur PS C.C No- 1461/2020 dtd- 11.11.2020 and GDE No- 399 dtd- 11.11.2020 then I received a telephonic Information that some local people gathered near Amanpur Bazar, Village- Amanpur under Amanpur GP and violating norms of covid-19 in such pandemic condition. Accordingly I informed this matter to my immediate Superior and as per his kind direction myself along with force reached at Amanpur Village under Amanpur GP at about 16:45 hrs and found that some 40/50 persons namely (1) Prabin Halder S/O- Chitta Halder (2) Bivas Maity S/O- Chandi Maity both of village Nayapara (3) Santosh Dolai S/O- Lt. So, I therefore pray before you kindly lodge a specific case against all above noted accused persons for committing offence U/S- 188/34 IPC and 51 of the Nation Disaster Management Act 2005.
