Most respectfully, I ASI/758 Pankaj Kr. De of Anandapur PS beg to state that while myself along with PSI- Suman Mallick and force i.e C/2385 Durjadhan Hajra, NVI- Sanjay Raj LC-2908 Soma Maity LC/2913 Trishn Kotal are performing Evining Mobile duty at Anchal No IX, Anandapur GP vide Anandapur PS C.C No- 1464/2020 dtd- 11.11.2020 and GDE No- 411 dtd- 11.11.2020 then I received a telephonic Information that some local people gathered near Rajardanga Village under Anandapur GP and violating norms of covid- 19 in such pandemic condition. Accordingly I informed this matter to my immediate Superior and as per his kind direction myself along with force reached at Rajardanga Village under Anandapur GP at about 16:05 hrs and found that some 20/25 persons namely (01) Nazrul Gayen S/O- Lt.
