In producing here with arrested accd. person namely Sandip Ghosh(38) S/O- Gunadhar Ghosh of Vill- Pebua, PO- Kanasole, PS- Anandapur, Dist- Paschim Medinipur along with the following seized articles as per seizure list . I, SI Amit Chatterjee of Anandapur PS do here by lodge a written complaint against the above noted accd. person to the effect that today (30.01.2021) at about 16:35 hrs duty officer PSI Suman Mallick of Anandapur PS received a credible information vide Anandapur PS GDE No- 1206 dt- 30.01.21 which was received from unknown caller over Telephone that a clandestine business of ID liquors is running illegally at village Pebua, Anchal No- VI, PS- Anandapur PS, Dist- Paschim Medinipur in the Tea stall of the above noted accd. person. After taking information of duty officer and as per direction of O/C Anandapur PS. I SI Amit Chatterjee left PS accompanied by detailed forces vide C.C. No- 367/21, dated- 30.01.21 and arrived the owner of the tea shop namely Sandip Ghosh was selling IS liquor from his tea shop seeing the police party the customers fled away. I also manage to detained the owner namely Sandip Ghosh. On demand the above noted accd. person failed to produced any valid license or documents in support of selling illegal ID liquor. As such I seized approx 20 Ltrs. ID Liquors containing two Jariken under proper seizure list duly signed by the accd. person and witnesses. During further interrogation the above noted accd. Person confessed his guilt. As such I arrested him after preparing memo of arrest and obtained his signature upon it after observing all formalities of Ld. Apex court.

The above noted arrested accd. person has committed an offence punishable U/S 46 (A) of The Bengal Excise Act and a FIR may kindly be registered against him and oblige.
