Sir,

With due respect I ASI -2393 Subrata Mukhopadhyay of Anandapur PS do here by lodge a suo moto complaint against unknown miscreants. Today (04/05/21) I was detailed for evening mobile duty in PS area vide Anandapur PS CC No- 1217/21 Dt-04/05/21 accompanied by C/1884 Lakhikanta Shit, NVF -0868 Ananta Mahata. In course of mobile duty received telephonic information from on duty officer that some unknown miscreants has damaged the house of one Kakali Mana (50) W/O- Lt. Dilip Mana of Sangrambar, PS - Anandapur, Dist- Paschim Medinipur. I reached at the house of Kakali Mana and talked with her. She told me that at about 16:15 hrs about 8/10 unknown miscreants suddenly came near her house and started abusing slang languages. She raised objection then unknown miscreants broken asbestos shed outside of her house and one among them assaulted her by lathi but no visible Mark of injuries. She couldn't identified the miscreants as they were outsider. I asked her to submit a complaint but she denied to lodge a complainant due to political fear.

Under the above facts and circumstances, I do hereby lodge a suo moto complaint against unknown miscreants as they have committed a cognizable offence and obliged.
