Sir,

In producing herewith arrested accd persons namely 01) Samir Nandi (34) S/O- Swaraj Nandi of Renuyat 2) Biswajit Kundu (38) S/O- Lt-Nirmal Kundu of Haripara, Anandapur both of PS- Anandapur, Dist- Paschim Medinipur with seized articles as per seizure list. I ASI- 2161 Supriya Samanta now posted at Anandapur PS, Dist -Paschim Medinipur do hereby lodge a suo moto complaint against 1) Samir Nandi(34) S/O Swaraj Nandi of Renuyat 2) Biswajit Kundu (38) S/O Lt-Nirmal Kundu of Haripara, Anandapur both of PS- Anandapur, Dist- Paschim Medinipur to the effect that today (21/05/21) I was detailed for evening mobile duty vide CC no- 1336/21, Date-21/05/21& Anandapur PS GDE No- 721, Date-21/05/21 in PS area. In course of mobile duty at about 15.05 hrs received information that arms and ammunities is being carried out by one Samir Nandi S/O Swaraj Nandi of Renuyat PS Anandapur. Informed the matter to my superior and also informed on duty officer of PS. As per kind direction of superior proceeded to work out on information. On getting information arrived at Haripara, Anandapur and pointed out by source detained a person and he disclosed his identity as Samir Nandi S/O- Swaraj Nandi of Renuyat, PS Anandapur. I offered him to search my person but he refused to do so. I asked him that I have got credible information that you are carrying arms and ammunities and with a view to recover arms and ammunities I have to search your person. At first he denied then agree, accordingly searched upon his person and found one live ammunition marked as "86 KF BMM" from his pocket. I asked him to produce valid documents of said ammunition but he failed to produce any valid documents. Seized the said ammunition under proper seizure list and obtained his signature upon it and arrested him after preparing memo of arrest. I interrogated him thoroughly and he disclosed that another ammunition is under possession of one Biswajit Kundu of Haripara, Anandapur and he is now at his house. I arrived at the house of Biswajit Kundu at Haripara, Anandapur accompanied by Samir Nandi and asked him to hand over ammunition which is now under his custody but he denied. I searched his house and found another ammunition marked as " 66 KF BMM" on cap which was kept under bedding. I asked him to produce valid documents of said ammunition but he failed to produce any valid documents. Accordingly seized said ammunition under proper seizure list and obtained his signature upon it and arrested him after preparing memo of arrest.

I therefore pray that a specific case may kindly be started against both the accd persons namely 1) Samir Nandi(34) S/O Swaraj Nandi of Renuyat 2) Biswajit Kundu (38) S/O Lt-Nirmal Kundu of Haripara, Anandapur both of PS- Anandapur, Dist- Paschim Medinipur under proper section of law as they have committed a cognizable offence which is punishable by law and obliged.
