With due respect I ASI Pankaj Kumar De of Anandapur PS do hereby lodge a suo moto complaint against unknown miscreants. Today (22.07.2021) myself along with force in course of my evening mobile duty vide Anandapur PS GDE No-972 dt-22.07.21 and CC No-2216 Dt- 22.07.21 as per order of OC, Anandapur PS I had been to the house of Susanta Pal S/O-Nemai Pal of Vill-Tapurua, PS-Anandapur, Dist-Paschim Medinipur and enquired into the petition of Susanta Pal vide Memo No-848/DEB dt-22.07.21 in presence of one Gour Hari Pal S/O Lt. Parameswar (uncle of the petitioner) as well as local residents.

During enquiry it revealed that the petitioner Susanta Pal is a supporter of Bhartiya Janata Party. After declaration of the result of assembly election 2021 the said Susanta Pal and his family members left their house. His house remained lock and key condition. On 03.05.21 at about 10.00 hrs some unknown miscreants attacked his house and damaged asbestor sheets on the roof. At present the house of the petitioner namely Susanta Pal was found lock and key condition. Some small portion of front side mud build wall of the said house had also been found damaged due to fall of rain water as learnt from the local people. I searched around his house and seized some pieces of broken asbestor sheets under proper seizure list duly signed by the witnesses. I also asked the local witnesses who were present at the time of enquiry about the particulars of the accused persons who had committed the offence but they failed to provide their particulars.

Under the above facts and circumstances I do hereby lodge a suo moto complaint against unknown miscreants who have committed this incident.
