

Sub: - F.I.R regarding theft of electricity u/s 135 (I) (b) of Electricity (amendment) Act, 2007 against
1) Sk. Seriful Islam , S/O-Lt. Ruhul Amin, 2) Sk. Montaj Ali, S/O- Sk. Golam Gilani and 3) Sk. Sajahan Ali, S/O of Lt. Sk. Ali Hosen all of Vill-Tangageria, PS-Anandapur, Dist-Paschim Midnapore.

Sir,
I, the undersigned, do hereby lodge a complaint empowered by the above Act, against the above mentioned accused persons for committing theft of electricity U/S 135 (I) (b) of the said act as stated here under.

Today, on 25/06/2018 at 12.20 pm. I, Sri Mansa Mal A.E. (E) & SM, along with Ashutosh Sharma, S.A.E. of Anandapur CCC, Arup Kr Singha Linesman of Anandapur CCC and Sri Basudeb Das Special Officer, Tapan Kr Mukhi Gr-1 TSH both of S&LP wing, Paschim Midnapore Regional Office inspected the Domestic Service Connection of Sk. Seriful Islam, Vill-Tangageria, PS-Anandapur, Dist-Paschim Medinipur who is a consumer of WBSEDCL vide Consumer ID-201783139. On inspection it was revealed that Sk. Seriful Islam was using electricity unauthorizedly for his house by means of bypassing the existing meter having no. TA513711. He had done this bypass by cutting the service cable before the meter (where the service cable is entering his house) and there from taping the line with the help of 2 no. 2.5 sq mm Copper core PVC cable having colour blue and red respectively. This bypass line then entered in the Cut-Out installed in the 1st floor and therefrom supplying this pilfered electricity to all parts of his house for running the electrical appliances including one no 1 HP Submersible Pump. Upon detection of theft we disconnected the Service Cable from the Pole and seized a portion of the Bypass Cables (Approx. 3 mtr each) along with 2 no. porcelain made JJ Champion make 30-32 Ampere, 415-500 volts Cut Out. As theft of electricity was detected I seized the above noted articles in presence of the inspection team and the accused duly signed by the inspection team members in the inspection report, seizure list and Label. In spite of request the accused and local people denied to sign in the inspection report, seizure list and Label. The seized articles were packed, labeled and sealed in the spot. We left the accused house at 12.50 pm after completion of all formalities. WBSEDCL has faced a huge revenue loss in this meter bypassing as a clear theft is detected.

On the same day at about 12.55 pm the inspection team inspected another house of Sk. Montaj Ali, S/O- Sk. Golam Gilani in the same village. On inspection it was revealed that the service connection of Sk. Montaj Ali was disconnected on 26.11.2013 due to non-payment of electricity bills. Subsequently the said service connection becomes DEEMED PERMANENT after six month of disconnection. It was also revealed that Sk. Montaj Ali cut opened the service cable before the meter (above the stair case) and there from tapped the line with the help of 2 no.7/20 SWG black colour PVC cable and connected this to his house wiring and thereby pilfering electricity and running the electrical appliances of his house. Upon detection of theft we disconnected the Service Cable from the Pole and seized a portion of the Bypass Cables (Approx. 3 mtr each). As theft of electricity was detected I seized the above noted articles in presence of the inspection team and the accused duly signed by the inspection team members in the inspection report, seizure list and Label. In spite of request the accused and local people denied to sign in the inspection report, seizure list and Label. The seized articles were packed, labeled and sealed in the spot. We left the accused house at 01.25 pm after completion of all formalities. WBSEDCL has faced a huge revenue loss in this meter bypassing as a clear theft is detected.

On the same day at about 01.30 pm the inspection team inspected another house of Sk. Sajahan Ali, S/O- Lt. Sk. Ali Hosen in the same village. On inspection it was revealed that Sk. Sajahan Ali was using electricity unauthorizedly for his house by means of bypassing the existing meter having no. H215998. He had done this bypass by cutting the service cable before the meter (where the service cable is entering his house) and there from taping the line with the help of 2 nos, 7/20 SWG black colour PVC cable and connected this to his house wiring and thereby pilfering electricity and running the electrical appliances of his house. Upon detection of theft we disconnected the Service Cable from the Pole and seized a portion of the Bypass Cables (Approx. 3 mtr each). As theft of electricity was detected I seized the above noted articles in presence of the inspection team and the accused duly signed by the inspection team members in the inspection report, seizure list and Label. In spite of request the accused and local people denied to sign in the inspection report, seizure list and Label. The seized articles were packed, labeled and sealed in the spot. We left the accused house at 03.05 pm after completion of all formalities. WBS&EDCL has faced a huge revenue loss in this *meter bypassing* as a clear theft is detected

So the above noted accused (1) Sk. Seriful Islam, (2) Sk. Montaj Ali and (3) Sk. Sajahan Ali have committed theft of Electricity u/s 135(I) (b) of Electricity act 2003 (Amendment Act 2007) and hence you are requested to take cognizance of the complaint and treat it as F.I.R.
