Sir,

I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 against Ajit Kolya, S/O : Lt. Bhangar Kolya, Vill : Khrigeria, PO : Khrigeria, PS : Anandapur Dist-Paschim Medinipur for committing theft of electricity and thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

On dated on 31.01.2023 I, Sri Dipak Kumar Majhi, DE & Station Manager along with Suvamoy Deb (SAE), Sanat Kumar Ghosh (LM) all attached to Upperkuai CCC and Sri Manik Chandra Lohar (SO(S&LP)), Gopal Yadav (TSH) are attached to the S&LP Unit, Paschim Medinipure Region Office entered into the Agriculture premises of the aforesaid accused person successively and inspected his hooking lines and property of WBSEDCL.

- 1) At about 6.45 Hrs, we inspected the agriculture meter of Ajit Kolya, S/O : Lt. Bhangar Kolya (con id-203274951, meter sl no-LX015448), Vill : Khrigeria, PO : Khrigeria, PS : Anandapur Dist-Paschim Medinipur, during inspection it is found that he was consuming electricity dishonestly and unauthorizedly by the way of direct hooking from the nearest DTR LT Bushing of WBSEDCL with the help of 03 nos single core 04 sq mm PVC covered yellow colored copper cable and connected to his agriculture water pump wiring. This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. As theft is detected I with the help of my staff disconnected the hooking line and seized some portion of core 04 sq mm PVC covered yellow colored copper cable measuring approx length 5 feet each with hooking arrangements preparing a seizure list duly signed by our inspection team members. We packed, labelled and sealed the seized articles at the spot and we left the safe place at about 7.10 Hrs. after making our all formalities

Here to note that in spite of request the representative of aforesaid accused person Ajit Kolya, S/O : Lt. Bhangar Kolya, Vill : Khrigeria, PO : Khrigeria, PS : Anandapur Dist-Paschim Medinipur and local people refuse to signature in the inspecting reports, seizer list and lables. In the above noted circumstances the above noted accused have committed theft of electricity and thereby he is liable to prosecuted U/S 135(1)(b) of Electricity Act 2003 (Amendment Act, 2007).

Hence, you are requested to take cognizance treating this complaint as FIR.

Observation : At the time of inspection to the STW premises of Ajit Kolya, 510-4t Bhanga Kolya at Vill P.O - Kharigoria, P.S - Arankpur it is found that the consumer consuming electricity dishonestly by passing the energy meter (LX015448) from by the way of direct hooking from nearby DTR LT busbar by 3 nos single core 4sqmm copper wire yellow coloured connected to his submersible pump P-T-I caused huge amount of Revenue loss of WBSEDCL.
