Sir,

In producing herewith the arrested charged person namely Rabindra Manna (64 Yrs) S/O-Lt Krishnaprasad Manna, of Vill+P.O-Toria, PS-Anandapur, Dist-Paschim Medinipur along with seized articles as per seizure list, I, SI Ashim Kumar of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (07.02.2023) at 22:45 hrs during my Mobile duty, vide C.C No. 300/23, dt:- 07.02.2023 & GDE No. 243, dt:- 07.02.2023 along with C/-2986 Bijoy Ghorai, NVF-572 Tanmay Adhikary and NVF-2425 Indrajit Das, all of Anandapur PS, received telephonic information from one of my reliable source that Rabindra Manna (64 Yrs) S/O-Lt Krishnaprasad Manna, of Vill+P.O-Toria, PS-Anandapur, Dist-Paschim Medinipur store huge quantity of illicit liquor, Bhahar and Molasses (Gur) in his house at Toria village for the purpose of sell. Accordingly I informed the matter to the superiors and as per their direction had been to Toria village.

At 23:05 hrs myself with my accompanied forces reached at the house of said Rabindra Manna S/O-Lt Krishnaprasad Manna, of Vill+P.O-Toria, PS-Anandapur, Dist-Paschim Medinipur and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of the house. On demand he could not produce any valid documents in favour of his illegal business. We searched the house of Rabindra Manna and seized the following articles in presence of local witnesses and the articles were labeled too by taking the signature of witnesses and the charged person at PO. Then I arrested him after observing all formalities as guided by the Apex Court of India.

The descriptions of the articles as follows -


- (1) One (1) White Colour Jaricane loaded with I.D Liquor. Approx 10 Ltrs. Locally called as "Chullu". Per Lts: Rs-60/-, marked as exhibit-'A'.
  - 1)(a) One plastic bottle which contain 01 Lts.(approx) ID liquor locally called as "Chullu", collected from exhibit 'A' marked as exhibit-'A1'.
- (2) One (1) plastic chat loaded with Bakhar (Bori) approx -10kg. Per kg Rs- 70/-, marked as exhibit-'B'.
  - 2) (a)One (1) plastic packet which contain 500(five hundred) grams bakhar (bari),collected from exhibit-'B', marked as exhibit-'B1'.
- (3) Two (2) tin loaded with Molasses (Gur).Per tin Rs-640/-, marked as exhibit-'C'.
  - 3) One (1) plastic jar which contain-1 kg, collected from exhibit-'C', marked as exhibit-'C1'.

Therefore, I pray a specific Case against the above noted charged person u/s 46 A(c) of Bengal Excise Act may kindly be started and arrange for its investigation.
