Sub: - F.I.R. against theft of Electricity.

Sir,
I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 to the effect that **Batul Ruidas, S/O : Dhirenda Ruidas, Vill : Suratganj, PO : Garsonapeta, P.S- Anandapur, Dist-Paschim Midnapur** committed theft of electricity and thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

Dated on 08.02.2023 at about 12:05 Hrs. I, Sri Dipak Kumar Majhi, DE & Station Manager Upperkuai CCC along with Suvamoy Deb (Jr Eng Gr-II), Laltu Nath(Sr.TSH), Sanath Kumar Ghosh(LM), all attached to Upperkuai CCC and Birendra Nath Maity(SO(E)), Manik Chandra Lohar (SO) and Subhadip Mitra(Sr. TSH) attached with Paschim Medinipure Regional Office S&LP wings entered into the agriculture premises of the Batul Ruidas and inspected his Agriculture Water Pump connection. During inspection it was found that Batul Ruidas, S/O: Dhirenda Ruidas was consuming electricity dishonestly by passing the energy meter-GX090191 by the way of direct hooking from DTR Kiosk of WBSEDCL with the help of 3 nos 7/16 aluminium cable of 2 nos Red and 01 no Black coloured PVC covered cable and directly connected to his agriculture pump for the purpose of watering of his agriculture field.

This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. The hooking lines of accused persons were disconnected.

A portion of the hooking accessories i.e. 3 nos 7/16 aluminium cable of 2 nos Red and 01 no Black coloured PVC covered approximated length of 3 meters along with hooking devices were duly seized and labelled by the undersigned in presence of the members of the inspection team at the site. In spite of request the accused and local witness representatives refused to sign on the seizure list, inspection report and labelled.

A copy of seizure lists and seized articles (duly packed, labelled and sealed at the site of inspection) are being submitted herewith. The inspection team left the aforesaid premises on completion of inspection at about 12:25 Hrs.

The aforesaid accused persons committed an offense & thereby he is liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007.

You are requested to take cognizance of this complaint and treat it as FIR.
