Sir,

In producing herewith the arrested charged person namely Kallol Ghosh (28 Yrs) S/O-Ghanashyam of Vill-Goharia, PS-Anandapur, Dist-Paschim Medinipur along with seized articles as per seizure list, I, SI Debasis Dutta of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (03.03.2023) at 16:45 hrs during my Special raid duty vide CC No. 559/23 dt: 03.03.2023 & GDE No. 90 dt: 03.03.2023 along with C/1897 Laxmikanta Mandi, NVF/235 Goutam Duley and HG/228 Swapan Lohar all of Anandapur PS, received telephonic information from one of my reliable source that Kallol Ghosh (28 Yrs) S/O-Ghanashyam of Vill-Goharia, PS-Anandapur, Dist-Paschim Medinipur store huge quantity of illicit liquor in his tea stall at Kandargeria mouza for the purpose of sell. Accordingly I informed the matter to the superiors and as per their direction had been to Kandargeria mouza

At 18:25 hrs myself with my accompanied forces reached at the tea stall of said Kallol Ghosh at Kandargeria mouza and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of tea stall. On demand he could not produce any valid documents in favour of his illegal business. We searched tea stall of said Kallol Ghosh at Kandargeria mouza and seized the following articles in presence of witness and the article is labeled too by taking the signature of witnesses and the charged person at PO. Then I arrested him after observing all formalities as guided by the Apex Court of India and NHRC. Grounds of arrest were informed to him and his relatives.

The descriptions of the articles as follows -

- (i) 01(one) plastic Jaricane which contain 07(Seven) Ltrs. (Approx) I.D Liquor locally called as "Chullu" marked as Exhibit 'A'. per litre Rs-60/- (In total -07 x 60=Rs-420/-)
- (ii) 01(one) plastic bottle which contain 01 Ltrs. (Approx) I.D Liquor locally called as "Chullu" collected from Exhibit 'A' marked as Exhibit "A1".

Therefore, I pray a specific Case against the above noted charged person namely Kallol Ghosh (28 Yrs) S/O-Ghanashyam of Vill-Goharia, PS-Anandapur, Dist-Paschim Medinipur u/s 46 A(c) Bengal Excise Act may kindly be started and arrange for its investigation.
