Sir,

I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 against Sukanta Ghosh(CON ID : 200884403), S/O : Subhankar Ghosh , Vill : Garabaga, PO : Toria , PS : Anandapur , Dist-Paschim Medinipur for committing theft of electricity and thereby he is liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

On dated 15.03.2023 I, Sri Dipak Kumar Majhi, DE&Station Manager along with Suvarneya Deb (JE(E) Gr II) , Laltu Nath(Sr.TSH), Sanat Kumar Ghosh (LM) all attached to Upperkuai CCC and Sri Birendra Nath Maity SO(E), Gopal Yadav (TSH) all are attached to the S&LP Unit, Paschim Medinipure Region Office entered into the Agriculture premises of the aforesaid accused person successively and inspected his hooking lines and property of WBSEDCL.

- 1) At about 06.00 Hrs, we inspected the agriculture premises of Sukanta Ghosh, S/O : Subhankar Ghosh , Vill : Garabaga, PO : Toria , PS : Anandapur , Dist-Paschim Medinipur during inspection it is found that he is consuming electricity dishonestly and unauthorizedly by the way of direct hooking from the nearest SMC Box LTOH AB Cable line of WBSEDCL with the help of 03 nos single core 7/16 SWG pvc covered red coloured round shaped aluminum cable by passing Energy Meter : RSX83894 . This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. As theft is detected I with the help of my staff disconnected the hooking line and seized some 03 nos single core 7/16 SWG pvc covered red coloured round shaped aluminum cable measuring approx length 06 feet each with hooking arrangements preparing a seizure list duly signed by our inspection team members. We packed, labelled and sealed the seized articles at the spot and we left the place at about 6.30 Hrs. after making our all formalities

Here to note that in spite of request the representative of local witness refused to sign and the WBSEDCL inspection team members signed in the inspecting reports, seizer list and lables.

In the above noted circumstances the above noted accused has committed theft of electricity and he is liable to prosecuted U/S 135(1)(b) of Electricity Act 2003 (Amendment Act, 2007).

Hence, you are requested to take cognizance treating this complaint as FIR.
