The complainant namely Chitta Panja has preferred the instant petition of complaint accusing Sukumar Gorai and 02 Ors of the commission of certain cognizable offences and has prayed for a direction upon the O.C of **Anandapur** P.S for registration of the same as FIR and for investigation. Complainant has also filed an affidavit swearing therein of non-registration of any case on the self-same allegation as on this date.

Perused the petition of complaint and the enclosures therein. The applicant is also verified on dock regarding the allegations brought forth. I is also seen that the provision of 154(1) and (3) of Cr.P.C have been complied with by the complainant. From the overall consideration of the aforementioned documents. I find that a cognizable offence has been disclosed and in order to arrive at a proper finding as to the prima-facie nature of the allegation this Court views it proper to send it to a competent and impartial agency for the verification of the credibility in the allegation and for thorough investigation.

As such, the prayer u/s 156(3) of Cr.P.C is hereby allowed. The O.C of **Anandapur** P.S is hereby directed to cause investigation into the case by treating the petition of complaint as an FIR after satisfying himself as to the non-registration of any earlier case on the self-same allegation between the parties and to submit the compliance report to this end.

A copy of this order along with the petition of complaint and its enclosures be sent to the O.C concerned for compliance.

The instant case is thus disposed of.

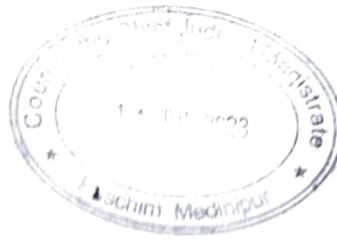
1. That your petitioner is a peace loving citizen of India, having residence in the respective address as mentioned in the cause title above.
