Sub: - F.I.R. against theft of Electricity.

Sir,

I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 to the effect that *Sentu Dolai (CON ID : 202054779)*, S/O : *Lt. Sudhir Dolai*, Vill : *Hizli*, PO : *Neradual*, P.S.-*Anandapur*, Dist-*Paschim Midnapur* committed theft of electricity and thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

Dated on 20.07.2023 at about 7.30 Hrs. I, Sri Dipak Kumar Majhi, DE & Station Manager Upperkuai CCC along with Suvamoy Deb (SAE), Sanath Kumar Ghosh (LM), all attached to Upperkuai CCC and Aniruddha Mondal (DE(E)), Subhadip Mitra (Sr. TSH), Manik Ch Lohar (S.O) all attached to S&LP unit Paschim Medinipur, entered into the commercial premises of the *Sentu Dolai* and inspected his domestic connection. During inspection it was found that *Sentu Dolai*, S/O : *Lt. Sudhir Dolai* was consuming electricity dishonestly and unauthorisedly by the way of direct hooking from near by single phase LTOH line of WBSEDCL with the help of 02 nos single core PVC covered 6 sq mm cable and directly connected to his out going side of cut-out of domestic connection circuit thus by passing energy meter : OB4435095. Details of findings were incorporated in the attached inspection report.

This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. The hooking lines of accused persons were disconnected.

A portion of the hooking accessories i.e. 02 nos single core PVC covered 6 sq mm aluminium cable along with two nos hooking device were duly seized and labelled by the undersigned in presence of the members of the inspection team at the site. In spite of request their representatives refused to sign on the seizure list.

A copy of seizure lists and seized articles (duly packed, labeled and sealed at the site of inspection) are being submitted herewith. The inspection team left the aforesaid premises on completion of inspection at about 7.50 Hrs.

The aforesaid accused persons committed an offense & thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007.

You are requested to take cognizance of this complaint and treat it as FIR.
