Sub: -FIR against theft of electricity.

Sir,

I, the undersigned, do hereby lodge a complaint being empowered by the Electricity Act 2003 and its amendment act 2007 against **Mirza Golam Mustafa(User)**, S/O-Late Aliur Rahaman Mirza of Village - Tangageria, PO-Keshpur, PS- Anandapur, Dist-Paschim Medinipur for committing theft of electricity U/S-135(1)(b) of Electricity Act 2003 and its amendment act 2007 as stated hereunder.

Today on 01.09.2023 at 13.00 hrs I, Sri Swapan Shit, S/O-Late Nagendranath Shit, AE & SM of Anandapur CCC along with Sri Manik ch Lohar, S/O-Late Atul ch Lohar, SO(S&LP), Aniruddha Mondal, S/O-Phatik Chandra Mondal, DE(E) S&LP, Sri Gopal Yadav, Sr.TSH, S/O- Ramkewal Yadav all of S&LP wing Paschim Medinipore Regional Office along with Tathagata Mukherjee, JE Gr-II, S/O - Shekhar Mukherjee and other technical staffs of Anandapur CCC entered into the **Commercial** premises of Mirza Golam Mustafa(User) and inspected his premises and properties of WBSEDCL.

During inspection it was found that Mirza Golam Mustafa(User), S/O-Late Aliur Rahaman Mirza of Village - Tangageria, PO-Keshpur, PS- Anandapur, Dist-Paschim Medinipur was consuming electricity dishonestly and unauthorizedly by the way of direct hooking from nearest LTOH line with the help of two nos single core 7/16 SWG PVC covered one black and one white aluminum cable and bypassing the energy meter DDT1595443(lie i.f.o Aliur Rahaman Mirza, Consumer ID-212168602) for running different electrical appliances in the extended premises of Ariya Enterprise in causing huge loss of revenue of WBSEDCL. As theft was detected I with the help of my staff disconnected the hooking line and service line and seized some portion of two nos single core 7/16 SWG PVC covered one black and one white aluminum cable approx length 5 feet each with hooking arrangement. I packed, labeled and sealed the seized article at the spot duly signed by our inspection team members. In spite of request the accused person and local witnesses refused to sign in the inspection report, seizure list and label. We left the premises at 13.30 hrs. after completion of all the formalities.

In the above noted circumstances the above noted the accused person **Mirza Golam Mustafa(User)**, S/O-Late Aliur Rahaman Mirza of Village - Tangageria, PO-Keshpur, PS- Anandapur, Dist-Paschim Medinipur has committed offence U/S-135(1)(b) of Electricity Act 2003 and its amendment Act 2007 for which he is liable to be prosecuted in the same section of law.

So you are requested to please take cognizance treating this complaint as an FIR.
