Sir,  
In producing herewith the arrested charged person namely Gour Das (approx 45 yrs), S/O-Lt Ponchu Das of Vill- Natunbazar, PS- Anandapur, Dist- Paschim Medinipur along with seized articles as per seizure list, I, SI Jayanta Banerjee of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (18.11.2023) at 17:45 hrs during my evening patrolling duty at PS area vide C C No. 2818/23 dt: 18.11.2023 & GDE No.699 dt: 18.11.2023 along with C/1884 Laxmikanta Shit and NVF 1897 Bunuram Mandi, all of Anandapur PS received a information from secrete source that one Gour Das (approx 45 yrs), S/O-Lt Ponchu Das of Vill- Natunbazar, PS- Anandapur, Dist- Paschim Medinipur storage huge quantity of "Chullu" in his own house at Natunbazar village under Anandapur PS for the purpose of sell. Accordingly I informed the matter to the superior and as per his direction had been to Natunbazar village. After arrival at PS search the available PS record and found that the above noted arrested person is a habitual of selling ID liquor there for one case vide Anandapur PS Case No-127/21, Dt- 14.11.2021 U/S- 46(A) B.E Act was registered against his name previously.

At 18:05 hrs myself with my accompanying forces reached at the house of one Gour Das (approx 45 yrs), S/O-Lt Ponchu Das of Vill- Natunbazar, PS- Anandapur, Dist- Paschim Medinipur and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is owner of this house. On demand he could not produce any valid documents in favour of his illegal business. We searched said house of said person and found the following articles accordingly I seized those articles in presence of witnesses and the articles were labeled to by taking the signature of witnesses and the charged person at PO. Then I arrested him after observing all formalities as guided by the Apex Court of India.

The descriptions of the articles as follows -

- 1) One (01) white colour Jarican loaded with Id liquor. Approx 10 liters. Locally called as 'Chullu'. Per litres Rs- 60/- marked as exhibit- 'A'.
  - 1) (a) One plastic bottle which contain 01 litres approx Id liquor Locally called as 'Chullu', collected from exhibit 'A' marked as exhibit 'A1'.
- 2) One (01) white colour Jarican loaded with Id liquor. Approx 10 liters. Locally called as 'Chullu'. Per litres Rs- 60/- marked as exhibit- 'B'.
  - 2)(a) One plastic bottle which contain 01 litres approx Id liquor Locally called as 'Chullu', collected from exhibit 'B' marked as exhibit 'B1'.
- 3) One (01) white colour Jarican loaded with Id liquor. Approx 05 liters. Locally called as 'Chullu'. Per litres Rs- 60/- marked as exhibit- 'C'.
  - 3)(a) One plastic bottle which contain 01 litres approx Id liquor Locally called as 'Chullu', collected from exhibit 'B' marked as exhibit 'C1'.

Therefore, I pray a specific Case against the arrested accused person Gour Das (approx 45 yrs), S/O-Lt Ponchu Das of Vill- Natunbazar, PS- Anandapur, Dist- Paschim Medinipur may kindly be started under Bengal Excise Act and arranged for its investigation.
