Sub: - F.I.R. against theft of Electricity.

Whereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 to the effect that **Ganesh Patar, S/O : Supratim Patar Vill : Rajapara, PO : Toria , P.S- Anandapur, Dist- Paschim Midnapur** committed theft of electricity and thereby they are liable to prosecute under section (1)(a) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

On 22.11.2023 at about 8.20 hr Hrs. I, Sri Dipak Kumar Majhi, DE & Station Manager Upperkuai CCC along with Suvamoy Deb (SAE), Sanath Kumar Ghosh (LM), all attached to Upperkuai CCC and Aniruddha Mandal (DE(E)), Gopal Yadav (Sr. TSH), Manik Ch Lohar (S.O) all attached to S&LP unit Paschim Medinipur entered into the domestic premises of the **Ganesh Patar** and inspected his domestic connection. During inspection it was found that **Ganesh Patar, S/O : Supratim Patar** was consuming electricity dishonestly and unauthorisedly by the way of direct hooking from near by single phase ACSR line of WBSEDCL with the help of 02 nos 7/16 SWG single core PVC covered aluminium cable white coloured and directly connected to his out going side of cut-out of domestic circuit and no meter was found in the said premises. Details of findings were incorporated in the attached inspection report. This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. The hooking of all accused persons were disconnected.

A portion of the hooking accessories i.e. 02 nos 7/16 SWG single core PVC covered aluminium cable white coloured approx. 6 feet each were duly seized and labelled by the undersigned in presence of the members of the inspection team at the site. In spite of request their representatives refused to sign on the seizure list.

A copy of seizure lists and seized articles (duly packed, labeled and sealed at the site of inspection) are being submitted herewith. The inspection team left the aforesaid premises on completion of inspection at about 8.40 Hrs.

The aforesaid accused persons committed an offense & thereby they are liable to prosecute under section (1)(a) of the Electricity Act, 2003 and its Amendment Act, 2007.

You are requested to take cognizance of this complaint and treat it as FIR.
