Sir,

In producing herewith the arrested charged person namely Ganesh Dewan (42 Yrs) S/O- Lt. Nemai Dewan of Vill- Satdubi, PS Anandapur, Dist-Paschim Medinipur along with seized articles as per seizure list, I SI Jay Naskar of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (30.12.2023) at 17:45 hrs during my Mobile duty, vide C.C No. 3083/23, dt:- 30.12.2023 & GDE No. 1120, dt:- 30.12.2023 along with NVF 1166 Ujjal Kar and NVF 2114 Surajit Panda both of Anandapur PS, received telephonic information from one of my reliable source that Ganesh Dewan (42 Yrs) S/O- Lt. Nemai Dewan of Vill- Satdubi, PS-Anandapur, Dist-Paschim Medinipur store huge quantity of illicit liquor in his house at Satdubi village for the purpose of sell. Accordingly I informed the matter to the superiors and as per their direction had been to Satdubi village.

At 18:45 hrs myself with my accompanied forces reached at the shop of said Ganesh Dewan (42 Yrs) S/O- Lt. Nemai Dewan of Vill- Satdubi, PS-Anandapur, Dist-Paschim Medinipur and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of the house. On demand he could not produce any valid documents in favour of his illegal business. We searched the house of Ganesh Dewan and seized the following articles in presence of local witnesses and the articles were labeled too by taking the signature of witnesses and the charged person at PO. Then I arrested him after observing all formalities as guided by the Apex Court of India.

The descriptions of the articles as follows -

- (1) One (01) white colour Jarican loaded with Id liquor. Approx 09 liters. Locally called as 'Chullu'. Per litres Rs- 60/- marked as exhibit- 'A'.
 - 1) (a) One plastic bottle which contain 01 liters approx Id liquor locally called as "Chullu" collect from exhibit 'A' marked as exhibit 'A1'.
- (2) One (01) white colour Jarican loaded with Id liquor. Approx 09 liters. Locally called as 'Chullu'. Per litres Rs- 60/- marked as exhibit- 'B'.
 - 2) (a) One plastic bottle which contain 01 liters approx Id liquor locally called as "Chullu" collect from exhibit 'A' marked as exhibit 'B1'.

Therefore, I pray a specific Case against the arrested accused person Ganesh Dewan (42 Yrs) S/O- Lt. Nemai Dewan of Vill- Satdubi, PS-Anandapur, Dist-Paschim Medinipur may kindly be started under Bengal Excise Act and arranged for its investigation.
