Sub: -FIR against theft of electricity.

Sir,

I, the undersigned, do hereby lodge a complaint being empowered by the Electricity Act 2003 and its amendment act 2007 against Prahlad Mondal (user), S/O-Late Nanda Mondal of Village -Kamarbandi, PO-Kongorerayma, PS-Anandapur, Dist-Paschim Medinipur for committing theft of electricity U/S-135(1)(b) of Electricity Act 2003 and its amendment act 2007 as stated hereunder.

Today on 02.01.2024 at 12.45 hrs I, Sri Swapan Shit, S/O-Late Nagendranath Shit, AE & SM of Anandapur CCC along with Sri Tathagata Mukherjee, JE.GR-II, S/O-Shekhar Mukherjee, Sri Nisith Pal, Sr. TSH, S/O-Tapan Pal and other technical staffs of Anandapur CCC entered into the domestic premises of Prahlad Mondal (user) and inspected his premises and properties of WBSEDCL.

During inspection it was found that Prahlad Mondal (user), S/O-Late Nanda Mondal of Village -Kamarbandi, PO-Kongorerayma, PS-Anandapur, Dist-Paschim Medinipur was consuming electricity dishonestly and unauthorizedly by way of bypassing an energy meter (Con ID-201894548; Meter No-B3619334) (this energy meter is registered in the name of Partha Sarathi Mondal who is a son of the above mentioned user) with the help of 2nos black coloured 7/20 SWG PVC covered aluminum cable and connected to his house wiring running different electrical appliances causing huge loss of revenue of WBSEDCL. As theft was detected I with the help of my staff disconnected the hooking line and the service line and seized some portion of 2nos black coloured 7/20 SWG PVC covered aluminum cable approx length 6 feet each with hooking arrangement. I packed, labeled and sealed the seized article at the spot duly signed by our inspection team members. In spite of request the accused person and local witnesses refused to sign in the inspection report, seizure list and label. We left the premises at 13.15 hrs. after completion of all the formalities.

In the above noted circumstances the above noted the accused person Prahlad Mondal (user), S/O-Late Nanda Mondal of Village -Kamarbandi, PO-Kongorerayma, PS-Anandapur, Dist-Paschim Medinipur has committed offence U/S-135(1)(b) of Electricity Act 2003 and its amendment Act 2007 for which he is liable to be prosecuted in the same section of law.

So you are requested to please take cognizance treating this complaint as an FIR.

During inspection it was found that Praklad Mandal was consuming electricity unauthorisedly and dishonestly with the help of 2 nos black coloured 7/20 SWG PVC covered Aluminium cable by bypassing energy meter ties in the name of Partha Sarathi Mondal and running different electrical appliances in his house causing WBSEDCL huge loss of revenue.
