Sir,  
I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 to the effect that **Sanjay Ghosh (ID - 213174878)**, S/O : **Lt. Rabindra Nath Ghosh**, Vill : **Maipur**, PO : **Toria**, Dist-Paschim Midnapur committed theft of electricity and thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

Dated on 03.01.2024 at about 08.23Hrs. I, Sri Dipak Kumar Majhi, DE&Station Manager Upperkuai CCC along with Suvamoy Deb (SAE), Sanath Kumar Ghosh (LM), all attached to Upperkuai CCC entered into the agriculture premises of the **Sanjay Ghosh**, S/O : **Lt. Rabindra Nath Ghosh** and inspected his agriculture connection. During inspection it was found that **Sanjay Ghosh**, S/O : **Lt. Rabindra Nath Ghosh** was consuming electricity dishonestly and unauthorisedly by the way of direct hooking from near by 10 KVA DTR's LT bushing with the help of 01 nos 3 core blue coloured copper wire and directly connected to his out going side of cut-out of agriculture pump circuit thus by passing energy Meter : LX603826. Details of findings were incorporated in the attached inspection report.

This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. The hooking lines of accused persons were disconnected.

A portion of the hooking accessories i.e. 01 nos 3 core blue coloured copper wire along with 02 nos hooking device were duly seized and labelled by the undersigned in presence of the members of the inspection team at the site. In spite of request their representatives refused to sign on the seizure list.

A copy of seizure lists and seized articles (duly packed, labeled and sealed at the site of inspection) are being submitted herewith. The inspection team left the aforesaid premises on completion of inspection at about 08.45 Hrs.

The aforesaid accused persons committed an offense & thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007.

**You are requested to take cognizance of this complaint and treat it as FIR.**

Rabindra Nath Ghosh was consuming electricity dishonestly and Unauthorizedly by the way of direct hooking from near by 10 KVA DTR's LT bushing with the help of 01 Nos 2.5 sqmm, 3 core copper wire blue coloured, and connected to the cut-out side of his agriculture Pump, thus by passing energy meter LX603826. This kind of theft causes huge Revenue Loss of WBSEDCL.

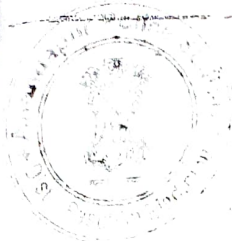
