Sir,

In producing herewith the arrested charged person namely Jayanta Karan (40Yrs) S/O- Lt. Bhaktipada Karan of Vill- Pebua, PS Anandapur, Dist Paschim Medinipur along with seized articles as per seizure list, I ASI Asis Kumar Banerjee of Anandapur PS lodged this complaint against the aforesaid person as suo moto to the effect that today (06.01.2024) at 20.25 hrs during my Naka Checking duty at Sakhisole more under Anandapur PS, as per order of superiors, vide C.C No- 43/24, dt- 06.01.2024 & GDE No- 213, Dtd- 06.01.2024 along with C/2986 Bijay Ghorai and NVF- 18121028 Jagadish Mahato, LHG- 1300242 Madhuri Sing all of Anandapur PS, at that time a man was coming from CK road side towards Solidiha village with a bicycle. Then I along with force stop him and checked and found that he had two beg tied behind his bicycle. I along with force checked his beg and found that he was carrying two Jarican loaded with Id liquor approx 21 liters (10+11) and one small plastic pouch bundle white colour along with paper thonga loaded some pieces of gaddar (rubber) for the purpose of sell. Then I apprehended him and asked him to show valid license regarding Id liquors. But, he did not show any valid documents regarding his carrying Id liquors. Accordingly, I informed the matter to the superiors. Being interrogated by me, he disclosed his above identity and confessed his guilt that he has carried the Id liquor illegal for purpose of sell. Then I seized the following articles in presence of witnesses and the articles were labeled too by taking the signature of witnesses and the charged person at PO

The descriptions of the articles as follows -

(1) One (01) Jarican loaded with Id liquor. Approx 10 liters. Locally called as 'Chullu'. Per litres Rs- 60/- marked as exhibit- 'A'.

1) (a) One plastic bottle which contain 01 liters approx Id liquor locally called as "Chullu" collect from exhibit 'a' marked as exhibit 'A1'.

(2) One (01) Jarican loaded with Id liquor. Approx 11 liters. Locally called as 'Chullu'. Per litres Rs- 60/- marked as exhibit- 'B'.

2) a) One plastic bottle which contain 01 liters approx Id liquor locally called as "Chullu" collect from exhibit 'B' marked as exhibit 'B1'.

(3) One (01) bicycle, (4) Two nylon begs, (5) Thirty five (35) small plastic pouch containing 100 ml white colour and 6) Some pieces of gaddar(rubber).

Then I arrested Jayanta Karan (40Yrs) S/O- Lt. Bhaktipada Karan of Vill- Pebua, PS-Anandapur, Dist-Paschim Medinipur him after observing all formalities as guided by the Apex Court of India. Therefore, I submitted a complaint against the arrested accused persons Jayanta Karan (40Yrs) S/O- Lt. Bhaktipada Karan of Vill- Pebua, PS-Anandapur, Dist-Paschim Medinipur and a specific case may kindly be started against him under 46A Bengal Excise Act and arranged for its investigation.
