Sir,  
I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 to the effect that **Sanjoy Mondal (CON ID : 200898629) S/O : Madan Mondal, Vill : Gohoria, PO : Burapat, PS : Anandapur, Dist-Paschim Midnapur** committed theft of electricity and thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

Dated on 09.01.2024 at about 07.30 Hrs. I, Sri Dipak Kumar Majhi, DE & Station Manager Upperkuai CCC along with Suvamoy Deb (SAE), Sanath Kumar Ghosh (LM), all attached to Upperkuai CCC entered into the agriculture premises of the **Sanjoy Mondal (CON ID : 200898629) S/O : Madan Mondal** and inspected his agriculture connection. During inspection it was found that **Sanjoy Mondal (CON ID : 200898629) S/O : Madan Mondal** was consuming electricity dishonestly and unauthorisedly by the way of direct hooking from near by 3 phase LT AB Cable line of WBSEDCL with the help of 03 nos 1.3 sq mm single core copper wire PVC covered white in coloured and directly connected to his out going side of cut-out of agriculture pump circuit thus by passing energy Meter : GX053890. Details of findings were incorporated in the attached inspection report.

This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. The hooking lines of accused persons were disconnected.

A portion of the hooking accessories i.e. 1.3 sq mm single core copper wire PVC covered white in coloured were duly seized and labelled by the undersigned in presence of the members of the inspection team at the site. In spite of request their representatives refused to sign on the seizure list.

A copy of seizure lists and seized articles (duly packed, labeled and sealed at the site of inspection) are being submitted herewith. The inspection team left the aforesaid premises on completion of inspection at about 08.50 Hrs.

The aforesaid accused persons committed an offense & thereby they are liable to prosecute under section 135(1)(b) of the Electricity Act, 2003 and its Amendment Act, 2007.

You are requested to take cognizance of this complaint and treat it as FIR.

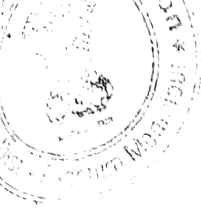

This kind of theft caused Huge Revenue Loss of WBSEDCL.
