Sir,

I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 to the effect that **Sajal Roy, S/O : Lt Jugal Kishore Roy, Vill : Palashtora, PO : Kharigera, PS : Anandapur, Dist-Paschim Midnapur** committed theft of electricity and thereby they are liable to prosecute under section 135(1)(a) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

Dated on 11.01.2024 at about 06.15 Hrs. I, Sri Dipak Kumar Majhi, DE&Station Manager Upperkuai CCC along with Suvamoy Deb (SAE), Sanath Kumar Ghosh(LM), all attached to Upperkuai CCC entered into the domestic premises of **Sajal Roy, S/O : Lt Jugal Kishore Roy** and inspected his domestic connection. During inspection it was found that **Sajal Roy, S/O : Lt Jugal Kishore Roy** was consuming electricity dishonestly and unauthorisedly by the way of direct hooking from near by 3 phase LT AB Cable line of WBSEDCL with the help of 01 nos 0.75 sqmm multi core copper wire black coloured PVC covered and directly connected to his out going side of cut-out of domestic circuit.

This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. The hooking lines of accused persons were disconnected.

A portion of the hooking accessories i.e. 0.75 sqmm multi core copper wire black coloured PVC covered cable were duly seized and labelled by the undersigned in presence of the members of the inspection team at the site. In spite of request their representatives refused to sign on the seizure list.

A copy of seizure lists and seized articles (duly packed, labeled and sealed at the site of inspection) are being submitted herewith. The inspection team left the aforesaid premises on completion of inspection at about 6.45Hrs.

The aforesaid accused persons committed an offense & thereby they are liable to prosecute under section 135(1)(a) of the Electricity Act, 2003 and its Amendment Act, 2007.

You are requested to take cognizance of this complaint and treat it as FIR.

9. Details of the Observation :

During inspection it has been found that Sajal Roy, S/O - Lt Sugata Biswas. Roy was consuming electricity by the way of direct hooking from nearby 3 phase LT line cable. The LT cable of WBSEDCL with the help of some OTS 60mm multicore copper wire, black coloured and directly connected to the cut out of his Domestic circuit. This kind of theft causes huge revenue loss of WBSEDCL.
