In producing here with the following arrested accused persons namely 1. Manik Khamrui (61) S/O- Lt. Sambhu Khamrui, (2) Chandrakanta Khamrui (32) S/O- Manik Khamrui and (3) Kalipada Khamrui (72) S/O- Lt. Sambhu all of vill- Akulsara, P.O- Garhsenapota, PS- Anandapur, Dist- Paschim Medinipur along with seized articles as per seizure list vide 325 pieces bomb (locally called as gach bomb), sutli 04 bandil approx weight 500 gm, Gun powder approx 2 kg, Chocklet bomb approx 80 pieces. Gunpowder mix rope approx 500 gm, Bamboo made basket carrying different type of explosive material weight approx 2 kg., gum cuted news paper. I SI Subir Majhi O/C Anandapur PS do here by lodge complaint against the above noted accused persons namely (1) Manik Khamrui (61) S/O- Lt. Sambhu Khamrui, (2) Chandrakanta Khamrui (32) S/O- Manik Khamrui and (3) Kalipada Khamrui (72) S/O- Lt. Sambhu all of vill- Akulsara, P.O- Garhsenapota, PS- Anandapur, Dist- Paschim Medinipur to the effect that today on 24.03.22 at 18.15 hrs received a secret source information that above noted arrested persons are making bomb and storage huge quantity of explosive items without any valid order under this PS area I noted the fact in GD book of Anandapur PS vide Anandapur PS. GDE No. 926 dt 24.03.22 at 18.15 hrs and myself along with ASI Subrata Mukhopadaya and force vide CC no 841 dt 24.3.21 vide GDE no 927 with Govt. vehicles having no WB 34 BN 1398 left for P.O Also directed mobile officer ASI Mahabir Mahata to wait at Akmura more. At about 19.25 hrs reached at Akumura village More and meet with mobile officer ASI Mahabir Mahata and I briefed all of my officers and force regarding the source information and proceed towards Akulsara village and 19.45 hrs we all are reached at Akmura bazaar and proceed towards the houses of arrested accused persons after keeping our police vehicle at quite distance. One party leaded by me and another was headed by ASI Mahabir Mahata. We reached at desired PO. At about 20.05 hrs and as per my instruction all my officers and force encircled the spot and there after suddenly rushed to the spot and apprehended above noted three persons and on examination they told their names and address as mentioned above we also searched their houses and discovered the following articles from the houses of above noted accused persons as noted against each (1) 211 pieces of bomb containing in a red colour plastic bag, 2) Sutli 02 bandil approx weight 250 gm, 3) Gun powder approx 1kg 250 gm, 4) Chocklet bomb approx 80 pieces. 5) Gunpowder mix rope approx 300 gm, gum in plastic carry bag, Sutli for set fire approx 1 kg. found from the house of 1. Manik Khamrai (61) S/O- Lt. Sambhu Khamrai, (2) Chandrakanta Khamrai (32) S/O- Manik Khamrai of Akulsara, PS- Anandapur and also found following 1) 114 pieces bomb, 2) Sutli 02 bandil approx weight 250 gm, 3) Gun powder approx 750 kg, 4) Chocklet bomb approx 80 pieces. 5) Gunpowder mix rope approx 200 gm, 6) Bamboo made basket carrying different type of explosive material weight approx 2 kg., 7) gum cuted news paper found from the house of Kalipada Khamrai S/O- Lt. Sambhu Khamrai of Vill- Akulsara, PS- Anandapur, Dist- Paschim Medinipur. On asked they failed to produce any valid license or any documents for keeping explosive articles and manufacturing such type of bomb (locally called as Gach bomb)

I seized those articles from their houses taking signature/LTI of each. I also prepared label of each seized articles. I prepared detailed seizure list, I arrested them after disclosing their ground of arrest after observing all legal formalities as laid down in Apex court and NHRC. They were informed about their grounds of arrest.

It is strongly established that the said accused persons committed an offence for causing negligent conducted with respect to fireworks illegally at their house premises without any valid documents or license which endanger human life or property.

As the above noted arrested persons committed an offence punishable an offence u/s 285/286 IPC & 24/25/26 W.B Fire Service Act and 9B The explosive Act 1884. Myself along with force return to PS on 24.03.22 at 22.25 hrs and started Anandapur P.S. Case No. 52/22 dt 24.03.22 u/s 285/286 IPC & 24/25/26 W.B Fire Service Act and 9B The explosive Act 1884 against the above noted accused persons as suo muto and directed SI Debasis Dutta to investigate the case.
