Sub: -FIR against theft of electricity.

I, the undersigned, do hereby lodge a complaint being empowered by the Electricity Act 2003 and its amendment act 2007 against **Mirja Musiur Rahaman, S/O-Mirja Rajab of Village-Jhatiara, P.O-Keshpur, P.S-Anandapur, Dist-Paschim Medinipur** for committing theft of electricity U/S-135(1)(b) of Electricity Act 2003 and its amendment act 2007 as stated hereunder.

Today on 12.05.2022 at 12.45 hrs. I, Sri Swapam Shit, S/O-Late Nagendranath Shit, AE& SM of Anandapur CCC along with Sri Birendra Nath Maity SO(Electrical), S/O-Late Satyalal Maity, Sri Manik Ashim Kr. Mitra all of S&LP wing Paschim Medinipore Regional Office along with Sri Tathagata Mukherjee, JE.GR-II, S/O-Shekhar Mukherjee Sri Arup Kumar Singha, Hr. Gr. Sr. LM, S/O-Murali Mohan Singha, Sri Kausik Das, Sr. TSH, S/O-Late Rabindranath Das and other technical staffs of Anandapur CCC entered into the premises of **Mirja Musiur Rahaman** and inspected his commercial premises and properties of WBSEDCL.

During inspection it was found that **Mirja Musiur Rahaman, S/O-Mirja Rajab of Village-Jhatiara, P.O-Keshpur, P.S-Anandapur, Dist-Paschim Medinipur** was consuming electricity dishonestly and unauthorizedly by the way of tampering his energy meter-OB4605522(Consumer ID-201077013), meter make-Bentec, Rating-5-30A, 240V, 50HZ with power drawn by tapping incoming service cable with the help of two nos single core 2.5sqmm PVC covered black coloured copper wire and connected to his commercial wiring for running different electrical appliances causing huge loss of revenue of WBSEDCL. As theft was detected I with the help of my staff disconnected the tampering line and service line and seized some portion of two nos single core 2.5sqmm PVC covered black coloured copper tampering wire approx. length 1.5 feet each preparing a seizure list duly signed by our inspection team members. I packed, labeled and sealed the seized article at the spot. In spite of request the accused person and representatives of the accused person and local witnesses refused to sign in the inspection report, seizure list and lable. We left the premises at 13.15 hrs. after completion of all formalities.

In the above noted circumstances the above noted the accused person **Mirja Musiur Rahaman, S/O-Mirja Rajab of Village-Jhatiara, P.O-Keshpur, P.S- Anandapur, Dist-Paschim Medinipur** has committed offence U/S-135(1)(b) of Electricity Act 2003 and its amendment Act 2007 for which he is liable to be prosecuted in the same section of law.

So you are requested to please take cognizance treating this complaint as an FIR.
