Sir, In producing herewith the arrested charged person namely Tarak Kamal (44 Yrs), S/O-Lt Moti Kamal, of Vill-Ghoradoura, PS-Anandapur, Dist-Paschim Medinipur along with seized articles as per seizure list, I, PSI Jay Naskar of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (25.05.2022) at 17:05 hrs during my Special raid duty vide C C No. 1308/22 dt: 25.05.2022 & GDE No. 998 dt: 25.05.2022 along with NVF 2416 Samir Dandapat, NVF-1415 Nemai Khamrui, NVF-0659 Swarup Mandal all of Anandapur PS, received telephonic information from one of my reliable source that Tarak Kamal (44 Yrs), S/O-Lt Moti Kamal of Vill- Ghoradoura PS-Anandapur, Dist-Paschim Medinipur store huge quantity of illicit liquor in his house at Ghoradoura for the purpose of sell. Accordingly I informed the matter to the superiors and as per their direction had been to Paruliya village.

At 18:05 hrs myself with my accompanied forces reached at the House of said Tarak Kamal at Ghoradoura village and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of the house. On demand he could not produce any valid documents in favour of his illegal business. We searched the house of Tarak Kamal and seized the following articles in presence of local witnesses and the articles were labeled too by taking the signature of witnesses and the charged person alike at PO. Then I arrested him after observing all formalities as guided by the Apex Court.

The descriptions of the articles as follows -

- (1) 122 (One hundred twenty two) sealed bottle each contain 600 ml Country Spirit labeled as Dilrua.
- (2) 34 (Thirty four) sealed bottle each contain 300 ml Country Spirit labeled as Bisal

Therefore, I pray a specific Case against the above noted charged person u/s 46 A Bengal Excise Act may kindly be started and arrange for its investigation.
