Sir,

In producing herewith the arrested charged person namely Lakhiram Tudu (40 Yrs) S/O-Lt Jiban Tudu, of Vill-Gopalbandh, PS-Anandapur, Dist-Paschim Medinipur along with seized articles as per seizure list, I, ASI Nema Saha of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (02.06.2022) at 07:45 hrs during my Morning Mobile duty, vide C.C No. 1379/22, dt:- 02.06.2022 & GDE No. 54, dt:- 02.06.2022 along with C/-690 Dilip Mandal, HG-0228 Swapan Lohar, all of Anandapur PS, received telephonic information from one of my reliable source that Lakhiram Tudu (40 Yrs) S/O-Lt Jiban Tudu, of Vill-Gopalbandh, PS-Anandapur, Dist-Paschim Medinipur store huge quantity of illicit liquor in his house at Gopalbandh for the purpose of sell. Accordingly I informed the matter to the superiors and as per their direction had been to Gopalbandh village.

At 13:05 hrs myself with my accompanied forces reached at the house of said Lakhiram Tudu at Gopalbandh village and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of the house. On demand he could not produce any valid documents in favour of his illegal business. We searched the house of Lakhiram Tudu and seized the following articles in presence of local witnesses and the articles were labeled too by taking the signature of witnesses and the charged person at PO. Then I arrested him after observing all formalities as guided by the Apex Court of India.

The descriptions of the articles as follows -

- (1) 01(One) White Colour Jaricane which contain 12 Ltrs. (Approx) I.D Liquor locally called as "Chullu".

Therefore, I pray a specific Case against the above noted charged person u/s 46 A Bengal Excise Act may kindly be started and arrange for its investigation.
