Sir,
I do hereby lodge complaint empowered by the Electricity Act, 2003 and its Amendment Act, 2007 against Sujit Samui , S/O : Kedar Nath Samui , Vill : Basudevpur ,PO : Sirsha PS : Anandapur , Dist-Paschim Medinipur for committing theft of electricity and thereby he is liable to prosecute under section 135(1)(a) of the Electricity Act, 2003 and its Amendment Act, 2007 as stated here under.

On dated 24.06.2022 I, Sri Dipak Kumar Majhi, AE&Station Manager along with Suvamoy Deb (JE(E) Gr II) , Laltu Nath(Sr.TSH), Sanat Kumar Ghosh (LM) all attached to Upperkuai CCC and Sri Birendra Nath Maity SO(E), Manik Chandra Lohar (SO) , Subhadip Mitra(Sr.TSH) all are attached to the S&LP Unit, Paschim Medinipur Region Office entered into the Domestic premises of the aforesaid accused person successively and inspected his hooking lines and property of WBSEDCL.

1) At about 12.20 Hrs, we inspected the house of against **Sujit Samui , S/O : Kedar Nath Samui , Vill : Basudevpur ,PO : Sirsha PS : Anandapur , Dist-Paschim Medinipur** during inspection it is found that he is consuming electricity dishonestly and unauthorizedly by the way of direct hooking from the nearest 1 Phase LTOH line of WBSEDCL with the help of 2 nos 1.0 sq mm PVC covered blue colored copper wire and connected to his house wiring and running different electrical appliances in his domestic premises.This theft of Electricity is resulting towards huge amount of Revenue loss of WBSEDCL. As theft is detected I with the help of my staff disconnected the hooking line and seized some portion 2 nos 1.0 sq mm PVC covered blue colored copper wire measuring approx length 06 feet each with hooking arrangements preparing a seizure list duly signed by our inspection team members. We packed, labelled and sealed the seized articles at the spot and we left the safe place at about 12.45 Hrs. after making our all formalities

Here to note that in spite of request the representative of aforesaid accused person refused to sign but the WBSEDCL inspection team members signed in the inspecting reports, seizer list and lables.

In the above noted circumstances the above noted accused has committed theft of electricity and he is liable to prosecuted U/S 135(1)(a) of Electricity Act 2003 (Amendment Act, 2007).

Hence, you are requested to take cognizance treating this complaint as FIR.
