Sub:-FIR against theft of electricity.

Sir,

I, the undersigned, do hereby lodge a complaint being empowered by the Electricity Act 2003 and its amendment act 2007 against **Tapan Bhunia, S/O- Sri Anil Bhunia** of Village- Dogerya ,PO-Saiyedbali, PS-Anandapur, Dist-Paschim Medinipur for committing theft of electricity U/S-135(1)(a) of Electricity Act 2003 and its amendment act 2007 as stated hereunder.

Today on 05.07.2022 at 11.50 hrs I,Sri Swapan Shit,S/O-Late Nagendranath Shit,AE & SM of Anandapur CCC along with Sri Birendra Nath Maity SO(Electrical),S/O-Late Satyalal Maity,Sri Manik Chandra Lohar,S/O-Lt Atul Chandra Lohar S.O(S&LP) PMRO and Gopal Yadav , TSH , S/O- Lt. Ramkewal Yadav all of S&LP wing Paschim Medinipore Regional Office along with Sri Tathagata Mukherjee,JE.GR-II,S/O-Shekhar Mukherjee, Sri Arup Kumar Singha, Hg Sr. LM, S/O-Murali Mohan Singha, Sri Kausik Das, Sr. TSH, S/O- Late Rabindranath Das and other technical staffs of Anandapur CCC entered into the premises of **Tapan Bhunia** and inspected his **commercial** premises and properties of WBSEDCL.

During inspection it was found that **Tapan Bhunia, S/O- Sri Anil Bhunia** of Village- Dogerya ,PO-Saiyedbali, PS-Anandapur, Dist-Paschim Medinipur was consuming electricity dishonestly and unauthorizely by the way of direct hooking from the nearest LTOH line with the help of two nos single core 7/22 SWG PVC covered one black and other faded red coloured aluminum wire and connected in his commercial premises and running different electrical appliances in his grocery shop causing huge loss of revenue of WBSEDCL. As theft was detected I with the help of my staff disconnected the hooking line and seized some portion of two nos single core 7/22 SWG PVC covered one black and other faded red coloured aluminum wire approx length 09 feet each with hooking arrangement preparing a seizure list duly signed by our inspection team members and the accused person. I packed, labeled and sealed the seized article at the spot. Inspite of request local witnesses refused to sign in the inspection report, seizure list and lable. We left the premises at 12.25 hrs. after completion of all the formalities.

In the above noted circumstances the above noted the accused person **Tapan Bhunia, S/O- Sri Anil Bhunia** of Village- Dogerya ,PO-Saiyedbali, PS-Anandapur, Dist-Paschim Medinipur has committed offence U/S-135(1)(a) of Electricity Act 2003 and its amendment Act 2007 for which he is liable to be prosecuted in the same section of law.

So you are requested to please take cognizance treating this complaint as an FIR.
