Sir,

In producing herewith the arrested charged person namely Sandip Ghosh (40 Yrs) S/O-Gunadhar Ghosh of Vill-Pebua, PS-Anandapur, Dist-Paschim Medinipur along with seized articles as per seizure list, I, ASI Nemaï Saha of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (22.07.2022) at 18:45 hrs during my Special raid duty vide SPL CC No. 1052 dt: 22.07.2022 & GDE No. 981 dt: 22.07.2022 along with NVF/572 Tanmoy Adhikary, NVF/2416 Samir Dandapat all of Anandapur PS, received telephonic information from one of my reliable source that Sandip Ghosh (40 Yrs) S/O-Gunadhar Ghosh of Vill-Pebua, PS-Anandapur, Dist-Paschim Medinipur store huge quantity of illicit liquor in his meat shop at Pebua for the purpose of sell. Accordingly I informed the matter to the superiors and as per their direction had been to Pebua village.

At 19:25 hrs myself with my accompanied forces reached at the house cum shop of said Sandip Ghosh at Pebua village and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of the meat shop. On demand he could not produce any valid documents in favour of his illegal business. We searched the meat shop of Sandip Ghosh and seized the following articles in presence of witness and the articles were labeled too by taking the signature of witnesses and the charged person at PO. Then I arrested him after observing all formalities as guided by the Apex Court of India and NHRC.

The descriptions of the articles as follows -

- (1) 19 bottles of 300 ml each of country Sprit styled as Birat (value 19x28=532)
- (2) 10 liter id liquor in a plastic Jaricane locally known as chullu.

Therefore, I pray a specific Case against the above noted charged person namely Sandip Ghosh (40 Yrs) S/O-Gunadhar Ghosh of Vill-Pebua, PS-Anandapur, Dist-Paschim Medinipur u/s 46 A Bengal Excise Act may kindly be started and arrange for its investigation.
