Sir,  
In producing herewith the arrested charged persons namely (1) Sankar Murmu (50 Yrs) S/O-Subal Murmu and (2) Biswanath Hembram (38 yrs) S/O- Lt Laxmiram Hembram both of Vill Bagakhali, PS-Anandapur, Dist-Paschim Medinipur along with seized articles as per seizure list, I, ASI Sk Robul Hossen of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today on 25.07.2022 at 08:05 hrs during my morning patrolling mobile duty vide CC No. 1816 dt: 25.07.2022 & GDE No. 1114 dt: 25.07.2022 along with LC/713 Samim Sultana and DYGC-0084 Santanu Roy SPL HG -0287 Subodh Ch. Hansda ,NVF-1415 Nimai Khamrui all of Anandapur PS, received telephonic information from one of my reliable source that Sankar Murmu (50 Yrs) S/O-Lt. Subal Murmu and (2) Biswanath Hembram (38 yrs) S/O- Lt Laxmiram Hembram both of Vill Bagakhali, PS-Anandapur, Dist-Paschim Medinipur store huge quantity of illicit liquor in his house at Bagakhali village for the purpose of sell. Accordingly, I informed the matter to the superiors and as per their direction had been to Bagakhali village.

At 08:35 hrs myself with my accompanied forces reached at the house of said Sankar Murmu at Bagakhali village and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of the house. We searched the house of said Sankar Murmu and seized (1) 20 liter id liquor containing in a plastic jaricane locally known as Chullu in presence of witness and the articles were labeled too by taking the signature of witnesses and the charged person at PO. On demand he could not produce any valid documents in favour of his illegal business. Then, I arrested him after observing all formalities as guided by the Apex Court of India and NHRC.

After that as per source information at 09:35 hrs myself with my accompanied forces reached at the house of said Biswanath Hembram at Bagakhali village. Being asked he disclosed his above identity and confessed that he is the owner of the house. Then we searched the house of said Biswanath Hembram and found that 20 liter id liquor containing in a plastic jaricane locally known as Chullu stored at the house of said person. On demand he could not produce any valid documents in favour of id liquor and illegal business . Accordingly I seized (1) 20 liter id liquor containing in a plastic jaricane locally known as Chullu in presence of witness and the articles were labeled too by taking the signature of witnesses and the charged person at PO. Then, I arrested him after observing all formalities as guided by the Apex Court of India and NHRC. I myself along with force and seized articles and seizure list with arrested accused persons left Bagakhali village for PS at 10:05 hrs .

Therefore, I pray a specific Case against above noted charged persons namely Sankar Murmu (44 Yrs) S/O-Lt. Subal Murmu and (2) Biswanath Hembram S/O- Lt Laxmiram Hembram both of Vill Bagakhali, PS-Anandapur, Dist-Paschim Medinipur u/s 46 of Bengal Excise Act may kindly be started and arrange for its investigation.
