Sir,

In producing herewith the arrested charged person namely Tarapada Hazari(26 Yrs) S/O- as per seizure list, I, ASI Subrata Mukhopadhyay of Anandapur PS lodged this complaint against the aforesaid person as suo-moto to the effect that today (13.08.2022) at 18:35 hrs during my Evening Mobile duty, vide C.C No. 1969/22, dt:- 13.08.2022 & GDE No. 490, dt:- 13.08.2022 along with DYGC/12084 Santanu Roy, NVF-0707 Sankar Murmu, all of Anandapur PS, received telephonic information from one of my reliable source that Tarapada Hazari(26 Yrs) S/O-Susthir Hazari, of Vill-Sahaspur, PS-Anandapur, Dist-Paschim Medinipur store huge quantity of illicit liquor in his house cum shop at Sahaspur for the purpose of sell. Accordingly I informed the matter to the superiors and as per their direction had been to Sahaspur village.

At 18:55 hrs myself with my accompanied forces reached at the house cum shop of said Tarapada Hazari at Sahaspur village and seeing the Police party, above noted charged person tried to take to his heel. But, before he could make his safe escape we chased and caught him up. Being asked he disclosed his above identity and confessed that he is the owner of the house cum shop. On demand he could not produce any valid documents in favour of his illegal business. We searched the house of Tarapada Hazari and seized the following articles in presence of local witnesses and the articles were labeled too by taking the signature of witnesses and the charged person at PO. Then I arrested him after observing all formalities as guided by the Apex Court of India.

The descriptions of the articles as follows -

- (1) 01(One) Plustic Jaricane loded with I.D Liquor aprox - 10(Ten) Ltr marked as exhibit A.
- (2) One plustic bottle containing with one (01) ltr Id. Liquor approx collected from exhibit A marked as exhibit A1.
- (3) One Plastic Jarcane loaded with Id. Liquor approx five (05) Ltr marked as exhibit B.
- (4) One Plustic bottle contain with one (01) Ltr Id. Liquor (approx) collected from exhibit B marked as exhibit B1.

Therefore, I pray a specific Case against the above noted charged person u/s 46 A Bengal Excise Act may kindly be started and arrange for its investigation.
