Sir,

With due respect and humble submission I beg state you that I ASI Mahabir Mahata now posted at Anandapur PS do hereby lodge a suo moto complaint against unknown miscreants to the effect that in course of mobile duty I received telephonic information from on duty table officer of Anandapur PS vide Anandapur PS GDE No- 279 dt. 08.09.21 and myself along with detailed force immediately proceed towards Bankata village to working out the information. After I reached the Tea Stall cum house of one SK Aynal S/O- SK Rousan of Bankata, PS- Anandapur, Dist- Paschim Medinipur, found a nylon bag lying near Tea Stall cum house of one SK Aynal which seems suspicious to me. In presence of local witness namely (1) SK Aynal S/O- SK Rousan and one disinterest witness Farid Khan(52) S/O- Lt. Nur Ali Khan both of Vill- Bankata, PS- Anandapur, Dist- Paschim Medinipur I searched the nylon bag and I found it contained 04 (four) Pcs. of materials seems to be a handmade bomb that were wrapped with Sutli, and can be believed to be heavy explosive.. It also came to light that some unknown miscreants have kept those things with intent to use upon their political rivals for creating nuisance at the area. Then I seized the said materials and the nylon bag in which bomb type materials were kept after preparing proper seizure list, duly signed by local witnesses. Under the said circumstances, I beg before your good office, to start a Suo-moto case against unknown miscreants for keeping explosives, with a view to use them upon human and property.

So, I pray before you that a case may kindly be started against unknown miscreants under proper section of law and also to arrange for its proper investigation.
