Sir,

In producing here with firecrackers under making proper seizure list duly signed by the witnesses to the effect that today 01.11.2021 at 15:25 hrs an anonymous telephone call came to the PS to the effect that at the house of Goutam Khamrai S/O- Kalipada Khamrai of vill- Akulsara, Mouja- Gotaugrasanja, PS- Anandapur, Dist- Paschim Medinipur that huge quantity of illegal fire crackers have got accumulated for the purpose of getting couriered to his respective customer. On receipt of this information diarized the fact vide Anandapur PS GDE No- 23 Dated- 01.11.2021. I PSI Jay Naskar, of Anandapur PS accompanied with C/2986 Bijoy Ghorai, NVF-572 Tanmay Adhikary, ILC-713 Samima Sultana left for the anticipated place for working out the information vide Anandapur PS GDE No- 24 Dt-01.11.2021 and Anandapur PS C.C. No- 3625/21 Dt-01.11.2021 by PS Govt. Vehicle. On reaching at village Akulsara I consulted with the accompanied forces and gave necessary instruction to them. I contacted with some local people and discuss the purpose of our visit at that place at that time and requested them to accompany us in that raid, but they did not agreed to accompany us.

After that we proceeded to the spot as prefixed by the anonymous called, we had been to the house compound of Goutam Khamrai S/O- Kalipada Khamrai of Akulsara, Mouja- Gotaugrasanja PS- Anandapur, Dist- Paschim Medinipur, for raid and search and we found the following articles are dumped at that place for getting dispatched to the respective sellers. It also noticed that preparing and packing of such articles in sacks. At that time we found that Goutam Khamrai S/O- Kalipada Khamrai of Akulsara, Mouja- Gotaugrasanja PS- Anandapur, Dist- Paschim Medinipur and his family members were absent in their house. Local public informed me that seeing the police party they flee away. After that I seized the following articles under proper seizure list duly sign by the Police witnesses, also packed all sized articles. It is strongly established that the said accused person committed an offence for causing negligent conducted with respect to fireworks illegally at his house premises without any valid documents or license which endanger human life or property.
